AN ORDINANCE EXTENDING THE CORPORATE LIMITS
OF THE CITY OF DETROIT LAKES, MINNESOTA TO INCLUDE CERTAIN
UNINCORPORATED TERRITORY COMPLETELY SURROUNDED
BY LAND WITHIN THE CITY LIMITS
(Cheryl Avenue)

WHEREAS, Certain territory described below is not presently included within the corporate limits of any incorporated city or borough; and

WHEREAS, This territory is completely surrounded on all sides by lands already included within the corporate limits of the City and is deemed to be urban or suburban in character.

The City Council of the City of Detroit Lakes, Minnesota does hereby ordain:

Section 1. Territory Annexed. The corporate limits of the City of Detroit Lakes are hereby extended to include the unplatted territory described as follows, which territory now, is, and heretofore been completely surrounded by territory already included within the City limits:

All those portions of land in the SE $\frac{1}{4}$ of Section 33, T139N R41W of the 5th Principal Meridian currently not in the corporate limits of Detroit Lakes described as follows:

The North Half of the SW $\frac{1}{4}$ of the said SE $\frac{1}{4}$

The NE $\frac{1}{4}$ of the said SE $\frac{1}{4}$

Section 2. Filing. The City Clerk is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of the County in which the property is located, the Township Clerk of the affected Township, and the Minnesota Municipal Board.

Section 3. Population. The population of the annexed territory is five.

Section 4. Effective Date of Annexation. This Ordinance takes effect on January 1, 2000 and after publication, the filing of certified copies as




