# AMENDED ANNEXATION ORDINANCE ORDINANCE NO. 71.4

AN ORDINANCE RELATING TO ANNEXATION OF LANDS AND AMENDING THE LEGAL DESCRIPTION AS CONTAINED IN ORDINANCE NO. \_\_\_\_\_\_.

The City Council of the City of Baxter, Minnesota, ordains:

WHEREAS, pursuant to a petition for annexation, the City of Baxter approved an annexation ordinance under Minnesota Statutes Section 414.033, Subd. 2(3), said ordinance having been adopted by the City Council at its meeting of September 7, 1999; and

WHEREAS, the adoption of said ordinance was subject to it being held and not finalized until such time as the Council would approve a further motion to send it to the State of Minnesota for approval; and

WHEREAS, the City's Engineer has recommended that the legal description as contained in the annexation ordinance adopted on September 7, 1999, be amended so as to include all highway and road rights of way, and as a result then reducing the size of the parcel to be annexed owned by Lewis Smith and Evelyn L. Smith so as to stay within the sixty-acre limit; and

WHEREAS, said amended legal description is attached hereto as Exhibit "A" and incorporated herein by reference as if fully set forth; and

WHEREAS, a map showing the area to be annexed as hereby amended is attached hereto as Exhibit "B" and incorporated herein by reference;

NOW, THEREFORE, the City of Baxter hereby amends Ordinance No. 71.3 so as to instead substitute and declare the property described in the attached Exhibit "A" to be annexed to the City of Baxter pursuant to the terms of the above statute, subject to a further motion by the Council to send it to the State of Minnesota for approval and thereafter subject to this amended ordinance being approved by the State of Minnesota and duly recorded with the Crow Wing County Recorder's Office. # ANNEXATION ORDINANCE ORDINANCE NO. 71, 3

AN ORDINANCE RELATING TO ANNEXATION OF LANDS

The City Council of Baxter, Minnesota, ordains:

WHEREAS, the City has received a petition for annexation under Minnesota Statutes Section 414.033, Subd. 2(3) from all owners of those certain parcels of real estate along the Highway 371 corridor described in said petition extending northerly from the existing City limits; and

WHEREAS, these parcels as a whole abut the current City limits of Baxter, consist of an area less than sixty (60) acres, are not presently served by public sewer facilities and public sewer facilities are not otherwise available; and

WHEREAS, after service of notice by certified mail more than thirty (30) days prior to the hearing upon Crow Wing County as the sole governing body for Unorganized Territory where said real estate is located, and upon all landowners within and contiguous to the area to be annexed, a public hearing was held by the City to receive input regarding the petition and to verify the information as set forth herein; and

WHEREAS, it is the intent of the City to cooperate with Crow Wing County following annexation in discussing and addressing storm water run off, wetlands and associated concerns along the corridor in conjunction with any planned development; and

WHEREAS, a copy of said annexation petition and a map showing the area to be annexed is attached hereto as Exhibit "A" and incorporated herein by reference;

NOW, THEREFORE, the City of Baxter hereby declares the property described below to be annexed to the City of Baxter pursuant to the terms of the above statute, subject to the ordinance being approved by the State of Minnesota, and subject to the City Council establishing an effective date for this ordinance following said approval, said land being described as follows, towit:

> That part of the Southeast Quarter of the Northeast Quarter of Section 31, Township 134, Range 28, lying East of Highway #371, except the following described parts:

1) Beginning at the East Quarter corner of said Section 31 and considering the east-west line of said Section 31 to be an east-west line, then North 74 degrees 34 minutes West 737.96 feet to a point on the centerline of the existing public road, thence South 15 degrees 26 minutes West to the South line of said East Half of the Northeast Quarter, then East 765.57 feet along said south line to the place of beginning, said excepted part being subject to easements of record;
