ORDINANCE NO. 274, 2ND SERIES

AN ORDINANCE ANNEXING PROPERTY ALONG LAKEVIEW DRIVE SW TO THE CORPORATE LIMITS OF THE CITY OF BEMIDJI (Schneider Property)

WHEREAS, certain properties, described below, are not presently included in the corporate limits of any incorporated city, village, or borough; and

WHEREAS, pursuant to M.S. 414.033, Subd. 2(3), the owner of said described properties have petitioned the City of Bemidji for annexation of such properties; and

WHEREAS, the properties are located adjacent to existing City boundaries and can receive city services; and

WHEREAS, the total area is 1.38 acres and is urban or suburban in character or about to become so; and

WHEREAS, there are 0 persons residing on the property; and

WHEREAS, the legal description of the property is as follows:

Parcel Nos. 03.00732.00 and 03.00731.00 - Auditor's Plat #2, Lot E, less the North 112 feet; and the North 112 feet of Lot E, Auditor's Plat #2.

NOW, THEREFORE, the Council of the City of Bemidji hereby ordains that the corporate limits of the City of Bemidji are hereby extended to include land as described, and the same is hereby annexed and included within the City of Bemidji as effectively as if it had originally been a part thereof.


This Ordinance shall become effective thirty (30) days after its passage, due publication thereof, and approval by the Minnesota Planning Agency.


