PETITION FOR ANNEXATION

TO THE CITY COUNCIL OF THE CITY OF SILVER LAKE
McLEOD COUNTY, MINNESOTA:

The undersigned, the fee owner of the territory described below, hereby requests a Petition that the said land be annexed to the City of Silver Lake and the City of Silver Lake boundaries be extended to include the same, and for that purpose, respectfully state as follows:

I.

That the territory to be annexed consists entirely of unplatted lands of approximately 5.63 acres in any area lying exclusively in Hale Township, McLeod County, Minnesota, described as follows, to-wit:

That said lands abut the Easterly boundary line of the present corporate limits of the City of Silver Lake (see attached Exhibit "B").

II.

Hale Township is entitled to notice of these proceedings pursuant to Minnesota Statute Section 414.033.

III.

The reason for this request for annexation is that said property is urban in character and will require municipal services to be provided by the City of Silver Lake, to-wit: water and sanitary sewer and other services which this request for annexation will permit.

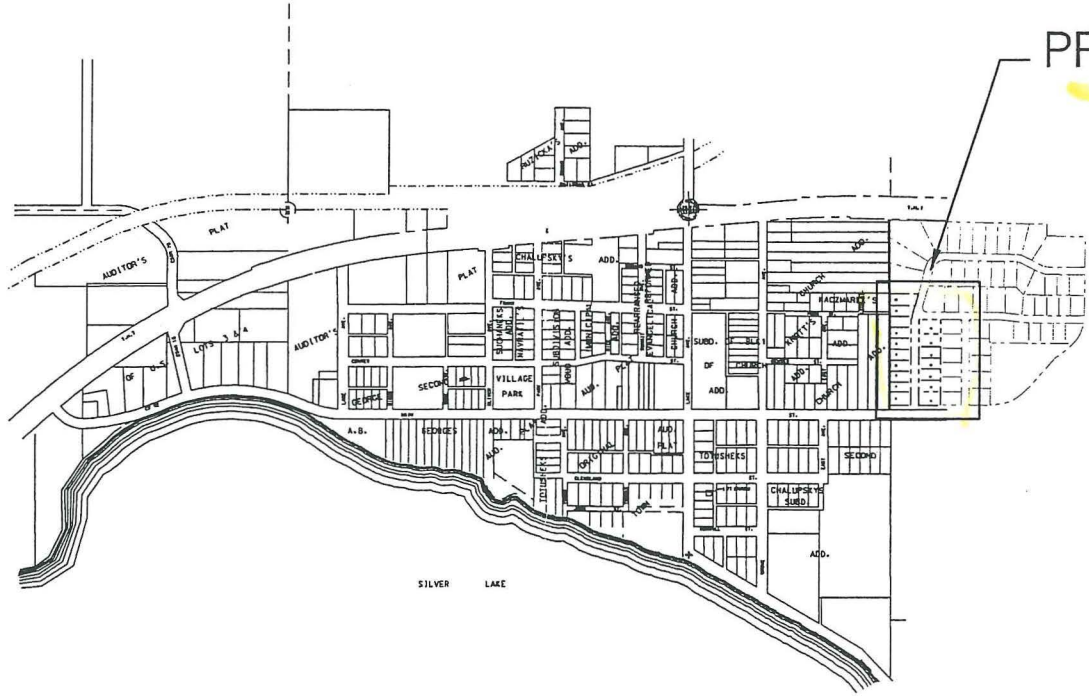

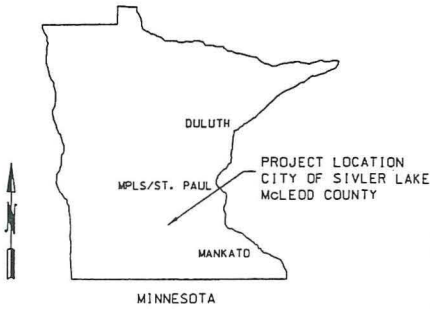
PROJECT LOCATION

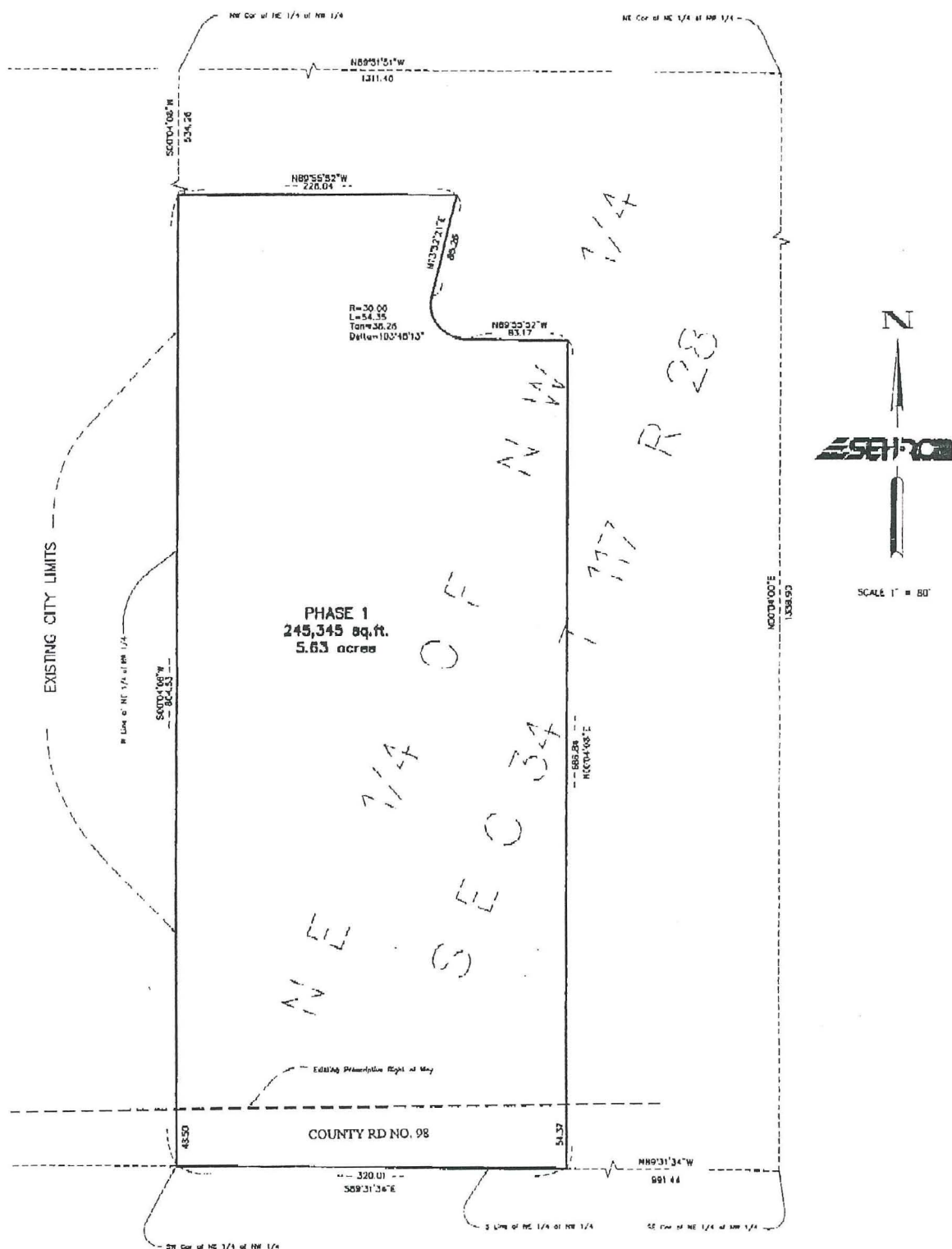
