## AN ORDINANCE DECLARING CERTAIN REAL PROPERTY BE ANNEXED TO THE CITY OF STURGEON LAKE PURSUANT TO MINN. STAT. 414.033, SUBD. 2(3)

The City Council of the City of Sturgeon Lake, Minnesota ordains:

**Section 1.** That part of the Northwest Quarter of Section Eighteen (18), Township Forty-five (45), Range Nineteen (19), West of the Fourth Principal Meridian, Pine County, Minnesota, which lies southerly of the North 1980.00 feet of said Northwest Quarter. Containing 40 acres, more or less and adjoins the City of Sturgeon Lake, Minnesota as shown on the attached sketch map of the PROPERTY, and,

The following tracts of land located in the Southwest Quarter of the Southwest Quarter of Section Seven (7), Township Forty-five (45) North, Range Nineteen (19) West of the Fourth Principal Meridian, Pine County, Minnesota, described as follows:

Commencing at the southwest corner of said Southwest Quarter of the Southwest Quarter, thence northerly, along the west line of the Southwest Quarter of the Southwest Quarter, a distance of 713.00 feet; thence easterly, parallel to the south line of said Southwest Quarter of the Southwest Quarter, a distance of 250.00 feet to the actual point of beginning of the tract of land herein described; thence westerly, along last described parallel line, a distance of 250.00 feet to said west line of the Southwest Quarter of the Southwest Quarter; thence southerly, along last described west line, a distance of 713.00 feet to said southwest corner of the Southwest Quarter of the Southwest Quarter; thence easterly, along said south line of the Southwest Quarter of the Southwest Quarter, a distance of 376.00 feet; thence northerly, parallel with said west line of the Southwest Quarter of the Southwest Quarter, a distance of 538.00 feet; thence easterly, parallel with said south line of the Southwest Quarter of the Southwest Quarter, a distance of 30.00 feet; thence deflecting to the left an angle of 131 degrees 22 minutes 52 seconds a distance of 233.21 feet to the point of beginning. Containing 6 acres, more or less and adjoins the City of Sturgeon Lake, Minnesota as shown on the attached sketch map of the PROPERTY, and,

Commencing at the southwest corner of the Southwest Quarter of the Southwest Quarter; thence easterly, along the south line of the Southwest Quarter of the Southwest Quarter, a distance of 376.00 feet to the actual point of beiginning of the tract of land herein described; thence continuting easterly, along said south line of the Southwest Quarter of the Southwest Quarter, a distance of 324.00 feet, thence northerly, parallel with the west line of said Southwest Quarter of the Southwest Quarter, a distance of 538.00 feet; thence westerly, parallel with said south line of the Southwest Quarter of the Southwest Quarter, a distance of 324.00 feet; thence southerly, parallel with said west line of the Southwest Quarter of the Southwest Quarter, a distance of 538.00 feet to the point of beginning. Containing 4 acres, more or less and adjoins the City of Sturgeon Lake, Minnesota as shown on the attached sketch map of the PROPERTY.

**Section 2.** The PROPERTY is not presently served by public sewer facilities or public sewer facilities are not otherwise available.

**Section 3.** All of the record fee owners of the PROPERTY have signed and delivered a petition to the City Clerk of the City of Sturgeon Lake, Minnesota, asking that the PROPERTY be annexed to the City of Sturgeon Lake, Minnesota.

**Section 4.** Minn. Stat. 414.033, Subd. 2(3) allows a municipality by ordinance to declare land annexed to it provided the requirements set forth in that Section are met.

All of the requirements set forth in that statute have been met with respect to the PROPERTY.

The PROPERTY is declared annexed to the City of Sturgeon Lake, Minnesota.

**Section 5. Effective Date.** This ordinance shall be effective upon its passage and publication.
