

ORDINANCE NO. 213**AN ORDINANCE EXTENDING THE CORPORATE
LIMITS OF THE CITY OF BRAHAM**

AN ORDINANCE extending the Corporate limits of the City of Braham to include certain unincorporated territory abutting upon the limits of the City and consisting of 200 acres or less for which a Petition for Annexation has been received from all property owners of the land.

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated City; and

WHEREAS, this territory abuts upon the corporate limits of the City along the West and North lines of the property and is deemed to be urban or suburban in character or about to become so; and

WHEREAS, this territory consists entirely of an area totaling 200 acres or less; and

WHEREAS, the municipality has received a valid Petition for Annexation from all the property owners of said land; and

WHEREAS, the population of said area to be annexed is zero (0); and

WHEREAS, the area to be annexed is not presently serviced by public sewer facilities or public sewer facilities are not otherwise available; and

WHEREAS, the Petitioner has given written notice and filed copies of the petition with the Town of Stanchfield, Isanti County and the Municipal Boundary Adjustments by U.S. Mail on December 10, 2001. More than 90 days has passed and no written objections to the Petition having been filed; and

SECTION 1. TERRITORY ANNEXED

The corporate limits of the City of Braham are hereby extended to include the unplatted territory described as follows, which territory abuts the municipality, consists of 65 acres more or less, and for which the municipality has received a valid Petition for Annexation from all the owners of said land:

Parcel as described on Exhibit "A" attached hereto.

SECTION 2. FILING

The City Clerk-Administrator is directed to file certified copies of this Ordinance with the Secretary of State, the County Auditor of Isanti County, the Town Clerk of Stanchfield Township and the Municipal Boundary Adjustments.

SECTION 3. EFFECTIVE DATE OF ANNEXATION

This Ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 2 and final approval by the Municipal Boundary Adjustments.



The Northwest Quarter of Southwest Quarter (NW 1/4 of SW 1/4) of Section One (1), Township Thirty-seven (37), Range Twenty-three (23), EXCEPTING the North 485 feet of the East⁸⁹⁵ feet thereof, as measured at right angles to the North and East lines of said NW 1/4 of SW 1/4.

SUBJECT TO the existing drainage ditch and subject to the existing County Road No. 54 along the North line thereof. Also subject to other easements, restrictions and reservations of record, if any.

AND

The Southwest Quarter of Southwest Quarter (SW 1/4 of SW 1/4) of Section One (1), Township Thirty-seven (37), Range Twenty-three (23), EXCEPTING THEREFROM the following described tract of land, to-wit: Commencing at the Southwest corner of said SW 1/4 of SW 1/4, thence East along the Section line for a distance of 40 rods; thence North and parallel with the West Section line for a distance of 20 rods, thence West and parallel with the South Section line for a distance of 40 rods and to the West Section line, thence South along the West Section line to the point of beginning and there to terminate.

SUBJECT TO County Road No. 4 along the South 50 feet thereof. Also subject to easements, restrictions and reservations of record, if any.
