ORDINANCE NO. 9-9-2002

AN ORDINANCE OF THE CITY OF EDGERTON, MINNESOTA, ANNEXING A PORTION O F THE NORTHEAST QUARTER (NE 1/4) OF THE SOUTHWEST QUARTER (SW 1/4) OF SECTION TWENTY-ONE (21), TOWNSHIP ONE HUNDRED FIVE (105) NORTH, RANGE FORTY-FOUR (44) WEST OF THE FIFTH (5TH) P.M., OSBORNE TOWNSHIP, PIPESTONE COUNTY, MINNESOTA, INTO THE CITY OF EDGERTON, MINNESOTA.

THE CITY OF EDGERTON ORDAINS:

Section 1. This annexation ordinance is being passed and adopted pursuant to the provisions of Minnesota statute §414.033, Subdivision 2, Subparagraph (3).

Section 2. On or about February 11, 2002 the City of Edgerton, Minnesota received a "Petition for Annexation of Real Property into the city of Edgerton, Minnesota" dated February 9, 2002, signed by Ronald Lee Menning, President; Rex Keller, Vice President; Kimberly Menning, Secretary; and Geraldine Keller, Treasurer; of Menning Plastics, Inc., a Minnesota corporation with offices in Edgerton, Minnesota.

Section 3. The area described in the Petition is under the control of the petitioners, abuts the limits of the City of Edgerton, Minnesota, contains 6.05 Acres or less, is not presently served by public sewer facilities, and is unpopulated.

Section 4. Pursuant to Minnesota statute §414.033, Subdivision 2, Subparagraph (3), a public hearing of the Petition was held by the Edgerton City Council at its regularly scheduled meeting commencing at 7:00 o'clock p.m. on March 27, 2002, notice of such hearing being published in the <u>Edgerton Enterprise</u> for two consecutive weeks; and mailed by certified return receipt requested mail on February 19, 2002, to Osborne Township and to all landowners within and contiguous to the area to be annexed. No objections to the Petition were heard by the Edgerton City Council at the public hearing.

Section 5. In their Petition the Petitioners waived the 30-day notice required by Minnesota statute §414.033, Subdivision 13, that the cost of electric utility service to the Petitioners may change if the subject real property is annexed into the City.

Section 6. This Ordinance corrects the legal description in Ordinance 3-27-2002 which incorrectly described the annexed tract as the "<u>West</u> Four Hundred Feet..." instead of the "<u>East</u> Four Hundred Feet..."

Section 7. The City hereby annexes real property situated in the Township of Osborne, County of Pipestone, State of Minnesota, legally described correctly as follows, to-wit: The East Four Hundred (400.00) feet of the South Six Hundred Fifty Eight and Two-thirds (658.67) feet of the Northeast Ouarter of the Southwest Ouarter of Section 21, Township 105 North, Range 44 West, 5th Principal Meridian, Pipestone County, Minnesota

Section 8. The township of Osborne waived its right to a 90-day objection period in a resolution adopted on February 9, 2002.

Section 9. The City Clerk/Treasurer is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Board, Osborne Township, the Pipestone County Auditor, and the Minnesota Secretary of State.

Section 10. This ordinance shall take effect and be in force from and after its passage and publication and be given the Number 9-9-02, after its approval by the Minnesota Municipal Board.
