AN ORDINANCE OF THE CITY OF SAINT PETER, MINNESOTA ANNEXING LAND LOCATED IN THE TOWN OF OSHAWA, NICOLLET COUNTY, MINNESOTA, PURSUANT TO MINN. STAT. 414.033, SUBD 2 PERMITTING ANNEXATION BY ORDINANCE

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city and abuts the corporate limits of the City of Saint Peter, Minnesota; and

WHEREAS, this territory is deemed to be urban or suburban in character; and

WHEREAS, a petition has been received which was signed by all owners of property within the territory subject to annexation by ordinance; and

WHEREAS, the property to be annexed includes approximately 30.75 acres of land; and

WHEREAS, there are no human inhabitants of the territory subject to annexation by ordinance; and

WHEREAS, the parcel to be annexed is not currently served by any City owned utility; and

WHEREAS, upon recommendation of the Planning and Zoning Commission, the City Council has determined that the annexation of the subject property is in conformance with the Comprehensive Plan of the City of Saint Peter; and

WHEREAS, on April 22, 2002, the City Council of the City of Saint Peter conducted a public hearing regarding the annexation of the subject property.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAINT PETER, NICOLLET COUNTY, MINNESOTA DOES HEREBY ORDAIN:

<u>Section 1</u>. Territory annexed. Pursuant to Minnesota Statute 414.033, the corporate limits of the City of Saint Peter are hereby extended by annexation of the unplatted property described as follows:

Parcel 1: Part of the Southwest Quarter of the Northeast Quarter of Section 17, Township 110 North Range 26 West, Nicollet County, Minnesota, described as:

Commencing at the North Quarter corner of Section 17, thence South 00 degrees 07 minutes 32 seconds West, (assumed bearing), along the North–South center line of Section 17 a distance of 1317.36 feet; thence South 89 degrees 54 minutes 32 seconds East, along the north line of the Southwest Quarter of the Northeast Quarter of Section 17 a distance of 334.43 feet to the point of beginning; thence South 00 degrees 07 minutes 32 seconds West, along a line parallel with the North–South center line of Section 17 a distance of 1317.08 feet to a point on the East–West center line of Section 17; thence South 89 degrees 55 minutes 23 seconds East, along said East–West center line, 983.28 feet to the southeast corner of the Southwest Quarter of the Northeast Quarter of Section 17; thence North 00 degrees 09 minutes 56 seconds East, along the East line of the Southwest Quarter of the Northeast Quarter of Section 17 a distance of 1317.07 feet to the northeast corner of the Southwest Quarter of Section 17; thence North 89 degrees 54 minutes 32 seconds West, along the north line of the Southwest Quarter of Section 17 a distance 984.26 feet to the point of beginning.
