ORDINANCE NO. 314, 2ND SERIES

AN ORDINANCE ANNEXING PROPERTY ALONG 30th STREET
TO THE CORPORATE LIMITS OF THE CITY OF BEMIDJI
(Brooks Property)

WHEREAS, certain properties, described below, are not presently included in the corporate limits of any incorporated city, village, or borough; and

WHEREAS, pursuant to M.S. 414.033, Subd. 2(3), the owner of said described properties have petitioned the City of Bemidji for annexation of such properties; and

WHEREAS, the properties are located adjacent to existing City boundaries and can be served with public utilities; and

WHEREAS, the total area is 3.6 acres and is urban or suburban in character or about to become so; and

WHEREAS, there are two (2) persons residing on the property; and

WHEREAS, the legal description of the property is as follows:

Parcel #31.00726.00 – Section 32, Township 147, Range 33, The East 215 feet of the South 490 feet of the Southeast quarter (SE ¼) of the Southwest quarter (SW ¼);

Parcel #31.00728.00 – Section 32, Township 147, Range 33, The West 185 feet of the East 400 feet of the South 490 feet of the Southeast quarter (SE ¼) of the Southwest quarter (SW ¼) less the South 308 feet;

Parcel # 31.00728.01 - Section 32, Township 147, Range 33, The West 100.01 feet of the East 500.01 feet of the South 490.01 feet of the Southeast quarter (SE ¼) of the Southwest quarter (SW ¼).

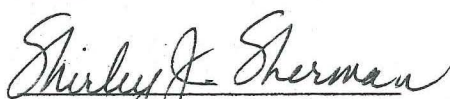
A total of 3.60 acres.

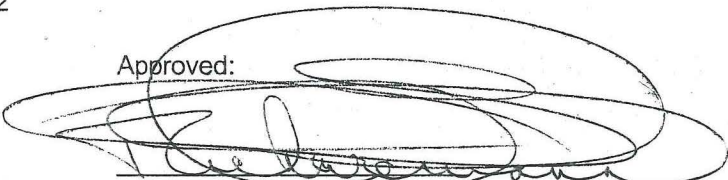
This Ordinance shall become effective thirty (30) days after its passage, due publication thereof, and approval by the Minnesota Planning Agency.
