

ORDINANCE NO. 908.01- 908.06  
AN ORDINANCE ANNEXING LAND OF ISD 182/ C.R.E.S.  
CONSISTING 27.74 ACRES  
TO THE CITY OF CROSBY PURSUANT TO  
MINNESOTA STATUTES 414.033, SUBD. 3

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, and

WHEREAS, the area proposed for annexation is 40 acres or less in size, is 60% or more bordered by land already within the corporate limits of the City of Crosby, and is not appropriate for annexation by ordinance pursuant to Minnesota Statutes 414.033, Subd 2(3); and

WHEREAS, the area proposed for annexation is described as follows:

That part of the NE $\frac{1}{4}$ NE $\frac{1}{4}$ , Sec. 12, Twp. 46, Rge. 29, described as follows: beginning at the iron monument at the Northwest corner of said NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; thence North 87 degrees 17 minutes 25 seconds East, assumed bearing 885.75 feet along the North line of said NE $\frac{1}{4}$ NE $\frac{1}{4}$ , to an iron monument; thence South 0 degrees 21 minutes 25 seconds East 1214.06 feet to an iron monument; thence North 87 degrees 17 minutes 05 seconds East 440.00 feet to an iron monument on the East line of said NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; thence South 0 degrees 29 minutes 18 seconds East 100.08 feet along the East line of said NE $\frac{1}{4}$ NE $\frac{1}{4}$  to an iron monument at the Southeast corner of said NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; thence south 87 degrees 17 minutes 05 seconds West 1325.98 feet along the South line of said NE $\frac{1}{4}$ NE $\frac{1}{4}$ , to an iron monument at the Southwest corner of said NE $\frac{1}{4}$ NE $\frac{1}{4}$ ; thence North 0 degrees 21 minutes 25 seconds West 1314.23 feet along the West line of said NE $\frac{1}{4}$ NE $\frac{1}{4}$  to the point of beginning.

WHEREAS, the area proposed for annexation abuts upon the corporate limits of the City of Crosby, Minnesota; and

WHEREAS, the area proposed for annexation is unincorporated, abuts on the city's East boundary and is not included within any other municipality; and

WHEREAS, the area proposed for annexation is approximately 27.74 acres in size; and

WHEREAS, the reason for the proposed annexation is to more easily resolve transportation, street improvement and street maintenance issues; Crosby is already providing water and sewer service; and to more easily resolve law enforcement, fire protection, administrative services and recreational facilities issues; and

WHEREAS, the nature of the area is education—the area is entirely occupied by Cuyuna Range Elementary School and its surrounding campus, parking lot and playgrounds; and

WHEREAS, the City of Crosby has complied with Minnesota Statutes 414.033, Subd. 13 (municipal electric utilities are not provided);

WHEREAS, the area proposed for annexation is not included in any other proceeding currently pending before Minnesota Planning; and

WHEREAS, the area proposed for annexation is not included in any area that has already been designated for orderly annexation pursuant to M.S. 414.0325.

WHEREAS, The area to be annexed is less than 40 acres; and

WHEREAS, the City of Crosby has served notice of intent to annex upon the town board on March 26, 2002; upon the the municipal board/ Minnesota Planning as of July 17, 2002; and a Waiver of Objection was received by the municipal board/ Minnesota Planning as of September 9, 2002. No objections have been received within the said 90 day period.

NOW, THEREFORE, the City Council of the City of Crosby does ordain as follows:

Section 1. The City Council hereby Determines that the following property is properly subject to annexation and the City has jurisdiction to annex the above described property to the City of Crosby.

Section 2. The corporate limits of the City of Crosby are hereby extended and increased so as to include and embrace within the corporate limits of the City of Crosby the territory described in paragraph 3 of the Preamble above, and such territory is hereby annexed and declared to be a part of the City of Crosby.

Section 3. The map attached to this Ordinance is an accurate map of the territory annexed, and the same is hereby adopted as the official map and plat of the territory annexed, which map and plat show the legal boundaries thereof, together with the avenues and streets and locations thereof, and the same are hereby dedicated to the public, if they have not already been dedicated, for public use.

Section 4. The mayor of the City of Crosby is hereby authorized and directed to certify that the

map is an accurate map of the territory annexed under the provisions of this ordinance.

Section 5. This Ordinance, with a copy of the official map attached hereto, shall be recorded in the office of the County Recorder of Crow Wing County, State of Minnesota.

Section 6. On the filing and recording of the copy of this ordinance, together with the attached official map, in the office of the Recorder for Crow Wing County, public rights-of-way, if any, within the property, shall also become rights-of-way within the City of Crosby.

Effective Date. This ordinance becomes effective upon its passage and publication according to law.
