ORDINANCE NO. 64

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF UNDERWOOD TO INCLUDE CERTAIN UNINCORPORATED PROPERTY OWNED BY MICHAEL D. WILDE AND MARY E. WILDE AND ABUTTING UPON THE LIMITS OF THE CITY

WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city; and

WHEREAS, the territory described below is 60 acres or less in size; and

WHEREAS, this territory abuts upon the corporate limits of the city at the northerly boundary thereof and is deemed to be urban or suburban in character; and

WHEREAS, this territory is owned in fee by Michael D. Wilde and Mary E. Wilde who has petitioned the city of Underwood to annex the territory described below.

The City Council of Underwood ordains:

Section 1. Territory Annexed. The corporate limits of the city of Underwood are hereby extended to include the property described as follows:

Sublot One (1) of Government Lot Six (6), of Section Thirty-two (32), Township One Hundred Thirty-three (133), Range Forty-one (41), Otter Tail County, Minnesota; and

Part of Government Lot Six (6), Section Thirty-two (32), Township One Hundred Thirty-three (133), Range Forty-one (41), Otter Tail County, Minnesota, described as follows: Beginning at the Northeast corner of Sublot 1 of Government Lot 6 in said Section, Township and Range, thence North 18 feet,

thence 210 feet Westerly along right of way of public road to intersecting road, thence Southerly 182 feet along right of way of public road to the North line of said Sublot 1 of Government Lot 6, thence East 275 feet along the North line of said Sublot 1 of Government Lot 6 to the point of beginning, containing approximately three-fourths acre.

Section 2. Filing. The city clerk is directed to file certified copies of this ordinance with the Secretary of State, the County Auditor of the county in which the property was located, the Town Clerk of the effected township and the Minnesota Municipal Board.

Section 3. Effective Date of Annexation. This ordinance takes effect upon the passage, publication and the filing of certified copies as directed in Section 2.
