

ORDINANCE NO. 4-2003

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLEEPY EYE TO INCLUDE CERTAIN UNPLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a petition dated February 20, 2003, requesting annexation of the territory hereinafter described is duly presented to the Council, and

WHEREAS, the quantity of land embraced within the area described in the petition is approximately 3.52 of an acre, more or less, no part of which is included within the limits of any incorporated city; and

WHEREAS, the petition was signed by all of the property owners in number, for the track to be annexed; and

WHEREAS, the land described in the petition abuts upon the City Limits and is urban or suburban in character.

NOW, THEREFORE, the City of Sleepy Eye does ordain as follows:

SECTION ONE. The City Council hereby determines that the annexation will be to the best interest of the City and of the territory affected, that the territory described herein abuts upon the City Limits and is urban or suburban in character, and that none of said territory is now included within the limits of any city and does not abut upon the limits of any other city.

SECTION TWO. The corporate limits of the City are hereby extended to include the unplatted land described as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part hereof.

The East 80 ft. of SE $\frac{1}{4}$ of SW $\frac{1}{4}$, Sec. 30, Twp. 110, Rge. 32, Brown County, MN., and the East 80 ft. of that part of Gov't Lot 4 being southerly of Lot A of Gov't Lot 4, Sec. 30, Twp. 110, Rge. 32, Brown County, MN.

SECTION THREE. The City Clerk has been directed to file certified copies of this Ordinance with Minnesota Planning, Secretary of State, the Home Township Clerk and the County Auditor-Treasurer.

SECTION FOUR. This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section Three and approval of Minnesota Planning.
