WHEREAS, the City Council of the City of Hinckley has received petition to annex certain property owned by Peter Remes in the County of Pine, State of Minnesota, described as follows:

The north 1633.23 feet of the west half of the southeast quarter (W ½ of SE ¼) of Section twenty-five (25) Township forty-one (41), Range twenty-one (21) lying west of Interstate Highway No. 35, Pine County, Minnesota.

pursuant to State Statutes 414.033 Subd. 5.

AND WHEREAS, the above described property is located in the Township of Hinckley, abuts existing municipal boundaries, and is approximately twenty-nine (29) acres in size,

AND WHEREAS, the City of Hinckley has filed copies of the annexation petition with Municipal Boundary Adjustments, the Hinckley Township Board, and the Pine County Board, and has not received any objections to the annexation petition within ninety (90) days of filing such petition,

AND WHEREAS, the Hinckley Planning Commission has reviewed this annexation petition and has recommended that the City proceed with annexation procedures with the condition that access road improvements are made to existing and future access points in accordance with City design standards,

AND WHEREAS, the Hinckley City Council has determined that the affected land is urban or suburban in character or is about to become so,

AND NOW THEREFORE, pursuant to Minn. Stat. § 414.033, subd. 5, the land described above is hereby annexed, added to and made part of the City of Hinckley, Minnesota, as if it had originally been a part thereof.

This ordinance shall take effect and be in force as of August 8, 2003, following its official publication and from and after the filing of a certified copy of hereof with the Minnesota Department of Administration Municipal Boundary Adjustments, the Hinckley Town Clerk, the County Auditor, and the Secretary of State.
