**THE CITY COUNCIL OF THE CITY OF GREEN ISLE MINNESOTA TO PROMOTE THE
PUBLIC SAFETY, HEALTH AND WELFARE, HEREBY ORDAIN AS FOLLOWS:**

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF GREEN ISLE TO
INCLUDE CERTAIN LAND ABUTTING THE CITY LIMITS OF GREEN ISLE.

WHEREAS, all of the title owners of the following described real estate have petitioned the City of Green Isle for annexation of the following described real estate to the city limits of Green Isle:

NE 1/4 of Section 13, Township 114 North, Range 27 West, Sibley County, Minnesota.

WHEREAS, the above described property is unincorporated, abuts the limits of the City of Green Isle, is not included within any other municipality, is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, and approximately 160 acres in size.

NOWHEREFORE, the City Council of Green Isle, Minnesota does hereby ordain:

Section 1. The City Council hereby determines and finds that the property abuts the municipality, that the property is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes 414.0325, that all title owners of the property have petitioned for its annexation, and that all of the provisions of Minnesota Statute 414.033 have been complied with.

Section 2. The property is urban in nature or about to become so.

Section 3. The corporate limits of the City of Green Isle are hereby extended to include the property and the same is hereby annexed to and included within the City of Green Isle as if the property had originally been a part thereof.

Section 4. The City Clerk-Treasurer is directed to file certified copies of this ordinance with the Minnesota Office of Strategic and Long Range Planning, Green Isle Township, the Sibley County Auditor and the Minnesota Secretary of State.



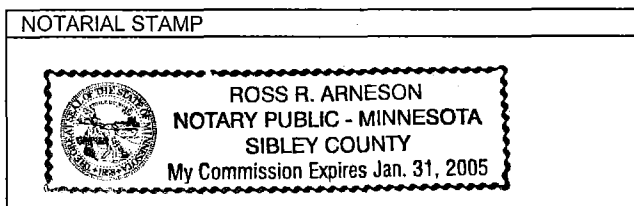
