To the Town Board of Detroit Township, Becker County

WHEREAS, The City Council of the City of Detroit Lakes intends to annex certain territory within the township of Detroit, described as follows:

ALL THAT PORTION OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 26, TOWNSHIP 139 NORTH, RANGE 41 WEST OF THE FIFTH PRINCIPAL MERIDIAN DESCRIBED AS FOLLOWS:

ALL THAT PORTION LYING NORTHERLY OF THE NORTH RIGHT OF WAY LINE OF TRUNK HIGHWAY 34, LYING WESTERLY OF THE CENTERLINE OF THE PELICAN RIVER SOUTHERLY OF THE NORTH LINE OF SAID SW ¼ OF THE NE ¼ AND EASTERLY OF THE EXISTING PUBLIC ROAD AND THE SOUTHERLY AND EASTERLY LINES OF THE PLAT OF STONEBROOKE VILLAS. SAID TRACT CONTAINS 13.2 ACRES.

WHEREAS, The above described land is forty (40) acres or less in area and 60 percent or more of its perimeter is bordered by land within the City of Detroit Lakes; and


