ORDINANCE NO. 822

AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CITY OF WASECA, MINNESOTA AND ESTABLISHING ZONING THEREOF

WHEREAS, Doris Born is the sole owner of the property described in Exhibit "A", attached hereto and incorporated herein by this reference (the Property); and

WHEREAS, The Property depicted in Exhibit "B" attached hereto and incorporated herein by this reference; and

WHEREAS, The property is completely surrounded by land within the municipal city limits; and

WHEREAS, Woodville Township and all landowners within and contiguous to the property have been given thirty (30) days notice by certified mail of the annexation; and

WHEREAS, A public hearing has been held in regards to the annexation; and

WHEREAS, Electric services provided to the area will not change following annexation.

NOW, THEREFORE, THE CITY COUNCIL OF WASECA, MINNESOTA DOES HEREBY DETERMINE, FIND AND ORDAIN:

- <u>Section 1</u>. That the Property described in Exhibit "A" is completely surrounded by the municipal city limits of Waseca.
- <u>Section 2</u>. That the Property is 2.15 acres in size, that the property is not served by public sewer facilities and public sewer facilities are not otherwise available.
- <u>Section 3</u>. That the above-described party is the sole owner of the property to be annexed by this ordinance.
- <u>Section 4</u>. That the corporate limits of the City of Waseca are extended to include the property and shall be zoned B-2 Highway Business upon annexation.
- <u>Section 5</u>. Certified copies of this ordinance shall be filed with Minnesota Planning, the Minnesota Secretary of State, the Waseca County Auditor, the Waseca County Recorder, and the Clerk of the Woodville Township Board.
