

ORDINANCE NO. 7 - 2003

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF SLEEPY EYE TO INCLUDE CERTAIN PLATTED LAND ABUTTING UPON THE CITY LIMITS.

WHEREAS, a petition dated April 25, 2002, requested annexation of the territory hereinafter described is duly presented to the Council, and

WHEREAS, the quantity of land embraced within the area described in the petition is approximately 1.03 of an acre, more or less, no part of which is included within the limits of an incorporated city; and

WHEREAS, the petition was signed by all of the property owners in number, for the tract to be annexed; and

WHEREAS, the land described in the petition abuts upon the City Limits and is urban or suburban in character.

NOW, THEREFORE, the City of Sleepy Eye does ordain as follows:

SECTION ONE. The City Council hereby determines that the annexation will be to the best interest of the City and of the territory affected, that the territory described herein abuts upon the City Limits and is urban or suburban in character, and that none of said territory is now included within the limits of any city and does not abut upon the limits of any other city.

SECTION TWO. The corporate limits of the City are hereby extended to include the platted land described as follows, and the same is hereby annexed to and included within the City as effectually as if it had originally been a part hereof:

Lot M-5 (also known as Lot M-5 of M-1) SE $\frac{1}{4}$, Sec. 29, Twp. 110, Range 32, Brown County, Minnesota.

SECTION THREE. The City Clerk has been directed to file certified copies of this Ordinance with the Director of the office of Strategic and Long-Range Planning, Secretary of State, the Home Township Clerk and the Brown County Auditor-Treasurer.
