A RESOLUTION FINDING THAT CERTAIN LAND IS SUITABLE FOR ANNEXATION BY THE CITY OF STACY

WHEREAS, the City of Stacy has received a petition from Paul E. Houston and Amy J. Houston requesting that the land described below be attached to the City:

Real estate legally described on attached exhibit A.

WHEREAS, notice has been given, and a public hearing has taken place, as required by Minnesota Statute Section 414.033 Subd. 2b; and

WHEREAS, based upon the evidenced produced at said public hearing, the City Council makes the following findings of fact:

- 1. <u>Sole Owners</u>. That, Paul E. Houston and Amy J. Houston, husband and wife, are the sole owners of the land to be annexed.
- 2. <u>Land Abuts the City</u>. That the land to be annexed abuts the City of Stacy on the city's southerly boundary and is not included within any other municipality. The land is located in the Township of Lent.
- 3. <u>Unplatted Land Containing Less Than 60 acres</u>. That the land to be annexed is unplatted and contains less than sixty (60) acres.
- 4. <u>Reason for Annexation</u>. The land to be annexed is suitable for development and the installation of municipal sewer and water service. The property is about to be developed with proposed use of water and sewer service from the City of Stacy.
- 5. <u>Urban or Suburban Character</u>. The land to be annexed is, or is about to become, urban or suburban in character.
- 6. <u>Sewer Facilities</u>. The land described to be annexed is not presently served by public sewer facilities and public sewer facilities are not otherwise available.
- 7. <u>No Other Annexation Pending</u>. The land described in paragraph one is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statute 414.0325.
- 8. <u>Electrical Utility Service</u>. Petitioners have been notified by the municipality that neither the cost nor service of electrical utility will change as a result of annexation, pursuant to Minn. Stat. Sec. 414.033, Subd. 13.


