ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF COLERAINE TO CONCLUDE CERTAIN LANDS OWNED BY EAGLE PROPERTIES ITASCA COUNTY, LLC, AND ABUTTING THE CITY OF GRAND RAPIDS.

WHEREAS, The City of Coleraine received a Petition from Eagle Properties, Itasca County, LLC, requesting annexation of the following described property:

The Northwest Quarter of the Northeast Quarter (NWl/4 NEl/4), the Northeast Quarter of the Northeast Quarter (NEl/4 NEl/4) EXCEPT the East 100 feet of the NEl/4 of NEl/4; the Northeast Quarter of the Northwest Quarter (NEl/4 NWl/4); the Southeast Quarter of the Northwest Quarter (SEl/4 NWl/4); and Government Lot One (1), all in Section Seven (7), Township Fifty-five (55), Range Twenty-four (24), West of the Fourth Principal Meridian, and

Subd. 5, and all of the provisions of Minnesota Statutes 414.033 have been complied with.

SECTION II

The property is urban in nature or about to become so.

SECTION III

The corporate limits of the City of Coleraine are hereby extended to conclude the property and the same is hereby annexed to and included within the City of Coleraine, as if the property had originally been part thereof.

SECTION IV

The City Clerk is directed to file certified copies of this Ordinance with the Minnesota Department of Administration, Municipal Boundary Adjustments, Town of Trout Lake, and the Itasca County Auditor, and the Minnesota Secretary of State.

SECTION V

This Ordinance takes effect upon its passage and publication and the filing of the certified copies as directed in Section IV and approval of the Ordinance by the State of Minnesota, Department of Administration, Municipal Boundary Adjustments.
