PETITION FOR ANNEXATION

Orland J. Aspen and Linda K. Aspen, the Petitioners, being first duly sworn upon oath, aver the following:

1. Petitioners, Orland J. Aspen and Linda K. Aspen, own the following described real property containing .73 acres, more or less, situated in Polk County, Minnesota:

The East Five (5) rods of the West Thirty (30) rods of the South Thirteen and one-third (13-1/3) rods of the Northwest Quarter of the Northwest Quarter (NW1/4NW1/4) of Section Three (3), Township One Hundred Forty-seven (147) North, Range Forty (40) West of the Fifth Principal Meridian; and also

The West Sixty-two and one-half (62-1/2) feet of the following described tract: Commencing at a point 30 rods East of the Southwest corner of the Northwest Quarter of the Northwest Quarter (NW1/4NW1/4) of Section Three (3), Township One Hundred Forty-seven (147) North, Range Forty (40) West; thence approximately 14 rods along the North line of Block 2, Stadsvold and Lohn's Addition to Fosston, to the Northeast corner of said Block 2; thence North at right angles 13-1/3 rods; thence West at right angles approximately 14 rods; thence South at right angles 13-1/3 rods to the point of beginning.

2. No other person or entity owns or has a fee interest in said property.

3. Said real property abuts the City of Fosston, Minnesota, is unplatted, and does not exceed two hundred acres. Further, no part thereof is included in another boundary adjustment proceeding pending before the Minnesota Municipal Board, and no other municipality borders said property.

4. Petitioners desire that said property be annexed to the City of Fosston, Minnesota, pursuant to Minnesota Statute 414.033, Subd. 5 and hereby request same.

5. Petitioners acknowledge that they were served with notice of electricity rate changes which will result from annexation as required by Minnesota Statute 414.033, Subd. 13. Petitioners hereby waive the 30 day notice requirement.

6. Petitioners have read the foregoing and know the same to be true except as to those matters stated on information and belief, and as to those matters, the petitioners believe them to be true.

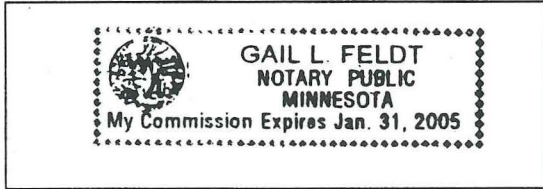

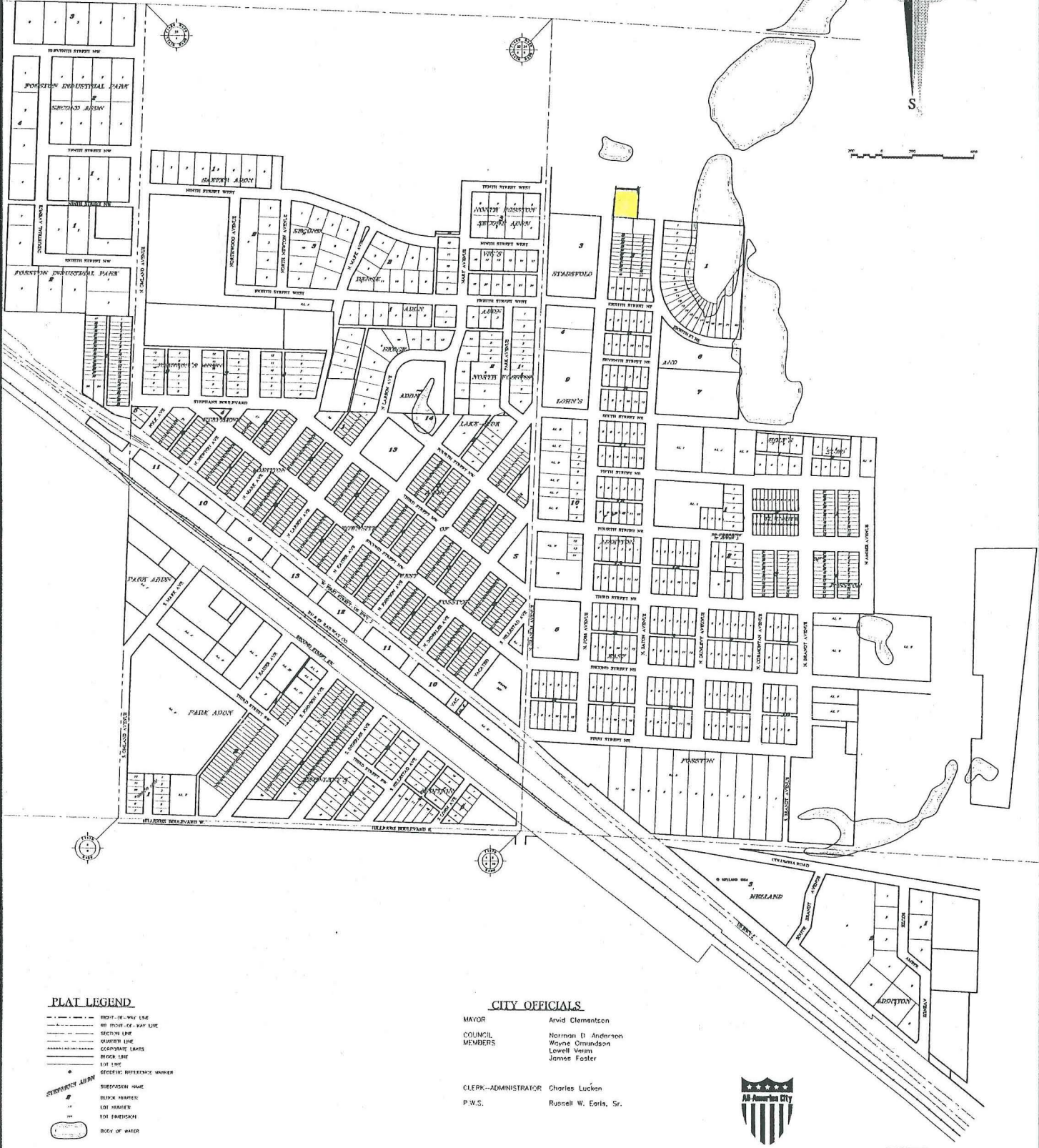
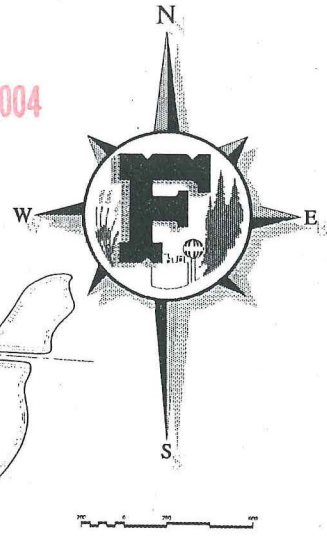
