#### **ORDINANCE NO. 210**

## AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF HENDERSON TO INCLUDE CERTAIN LAND NOT EXCEEDING 60 ACRES IN AN AREA ABUTTING UPON THE CITY LIMITS AND OWNED BY THE CITY OF HENDERSON

WHEREAS, effective October 3, 2003 the area described as 3.71 acres of land shown as *Park* on the plat of Oak View Heights in Section 12, Township 112, Range 26, Henderson Township, Sibley County, no part of which is included within the limits of an incorporated city, village, or borough was deeded to the City of Henderson by Sibley County and Henderson Township; and

WHEREAS, Subdivision 2, clause 1 of Section 414.033., Annexation by ordinance, of Minnesota State Statutes provides for a municipality to annex such property if it meets this condition.

NOW THEREFORE THE CITY COUNCIL OF HENDERSON, MINNESOTA does hereby ordain that:


Section 1. The City Council hereby determines (1) that the annexation will be in the best interests of the City and the area to be annexed; (2) that the property described herein abuts the City limits and is about to become urban or suburban in character; and (3) that none of said property in now included within the limits of any city, village, or borough.

Section 2. The corporate limits of the City of Henderson are hereby extended to include the area to be annexed described as 3.71 acres of the land indicated as *Park* in the plat of Oak View Heights in Section 12, Township 112, Range 26, Henderson Township, Sibley County, Minnesota and the same is hereby annexed to and included within the City of Henderson as if it had originally been a part thereof.

Section 3. The City Clerk-Administrator is hereby directed to file certified copies of this Ordinance with the Minnesota Municipal Boundary Adjustments group of the Department of Administration, Henderson Township, the Secretary of State, and the Sibley County Auditor.


