AN ORDINANCE ANNEXING CERTAIN LAND INTO THE CORPORATE LIMITS OF THE CITY OF MAYER, CARVER COUNTY, MINNESOTA

DATED: SEPTEMBER 13, 2004

THE CITY COUNCIL OF THE CITY OF MAYER, CARVER COUNTY, MINNESOTA, ORDAINS:

- Section 1. Statement of Character of Land. The City of Mayer is the fee owner of certain land described below which presently abuts the corporate limits of the City, is not within the corporate limits of any incorporated city and is deemed to be urban or suburban in character.
- Section 2. Land Annexed. Pursuant to Minnesota Statutes Section 414.033, Subd. 2, Clause 1, the corporate limits of the City of Mayer are hereby declared extended to encompass and include all that certain land situated in the County of Carver and legally described as follows:

For legal description see Exhibit "A" attached hereto and made a part hereof.

- Section 3. Filing. The City Clerk-Treasurer is hereby directed to file copies of this Ordinance with the Minnesota Department of Administration - Municipal Boundary Adjustments, the Town Clerk of the Town of Water Corver County Auditor, and the Minnesota Secretary of State and to publish this Ordinance in the Carver County News, all as required by law.
- Effective Date of Annexation. This Ordinance takes effect upon its passage Section 4. and publication and the filing of copies as directed in Section 3 and approval by the Minnesota Department of Administration - Municipal Boundary Adjustments.


EXHIBIT "A"

LEGAL DESCRIPTION

That part of the South 293.00 feet of the Southwest Quarter of Section 31, Township 117, Range 25, Carver County, Minnesota, lying east of the West 241.725 feet of said Southwest Quarter and lying west of the following described line:

Commencing at the northwest corner of Section 6, Township 116, Range 25, said corner being a point on the south line of said Southwest Quarter of Section 31; thence South 89 degrees 49 minutes 11 seconds East, assumed bearing along the south line of said Southwest Quarter, a distance of 180.60 feet to the point of beginning of the line to be described; thence North 00 degrees 35 minutes 01 second West, parallel with the west line of said Southwest Quarter, a distance of 293.03 feet to the north line of the South 293.00 feet of said Southwest Quarter and said described line there terminating.
