AN ORDINANCE ANNEXING CERTAIN LANDS INTO THE CITY OF WASECA, MINNESOTA AND ESTABLISHING ZONING THEREOF

WHEREAS, James and Marian Keller are the owners of the properties, incorporated herein by this reference (the **Properties**); and

WHEREAS, the Properties consists of two (2) parcels of land and are described in Exhibit "A" and depicted in Exhibit "B" attached hereto and incorporated herein by this reference; and

WHEREAS, the Properties abut the limits of the City of Waseca, that the Properties are less than 60 acres in size, that the Properties are not served by public sewer facilities and that public sewer services are not otherwise available, the above described party is the sole owner of the Properties and have petitioned the improvements, that is not included within any other municipality, and that the electric services provided to the site will not change upon annexation; and

NOW, THEREFORE, THE CITY COUNCIL OF WASECA, MINNESOTA DOES HEREBY DETERMINE, FIND AND ORDAIN:

- <u>Section 1</u>. That the Properties abut the City of Waseca's southwestern border at the corner of Lake Street NW and Highway 14.
- <u>Section 2</u>. That the Properties together equal less than 60 acres in size, that the Properties are not served by public sewer facilities and public sewer facilities are not otherwise available. The two parcels together total 0.66 acres.
- <u>Section 3.</u> That above described party is the sole owner of the Properties and have petitioned the improvements.
- <u>Section 4</u>. The corporate limits of the City of Waseca are extended to include these properties.
- <u>Section 5.</u> That 30 days has lapsed between the receipts of certified notices to Woodville Township and all landowners in and contiguous to the properties and a public hearing was held on this matter.
- <u>Section 6</u>. Certified copies of this ordinance shall be filed with The Department of Administration (Municipal Boundary Adjustments), the Minnesota Secretary of State, the Waseca County Auditor, The Waseca County Recorder, and the Clerk of the Woodville Township Board.
- <u>Section 7</u>. This ordinance shall be effective: upon passage and legal publication and filing of the certified copies as described in Sections 5 and 6; and, upon approval of the Ordinance by The Department of Administration, Municipal Boundary Adjustments.

Section 8. Upon annexation these parcels will be zoned R-2, Urban Residential.
