ORDINANCE NO. 11,002.00

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF CLEVELAND TO INCLUDE CERTAIN LAND NOT EXCEEDING 60 ACRES IN AN AREA ABUTTING UPON THE CITY LIMITS

WHEREAS, a certain petition dated February 28, 2005 requesting annexation to the territory hereinafter described was duly presented to the City Council on March 1, 2005; and

WHEREAS, the quantity of land embraced within the area described in the petition and bounded as described is 2 acres of land, no part of which included within the limits of an incorporated city, village, or borough; and

WHEREAS, the petition is signed by all owners; and

WHEREAS, the property abuts the City of Cleveland; and

WHEREAS, the area to be annexed is 60 acres or less; and

WHEREAS, the area to be annexed is not presently served by public sewer facilities or public sewer facilities are not otherwise available; and

WHEREAS, pursuant to Minnesota Statute, a property meeting these conditions is deemed to be urban or suburban in character or about to become so.

WHEREAS, a public hearing was held on April 4, 2005 after giving 30 days written notice by certified mail to Cleveland Township and to all landowners within and contiguous to the area to be annexed.

The City Council of Cleveland, Minnesota does ordain:

Section 1. The City Council hereby determines (1) that the annexation will be in the best interests of the City and the area to be annexed; (2) that the property described herein abuts the City limits, and is about to become urban or suburban in character; and (3) that none of said property is now included within the limits of any city, village, or borough.

Section 2. Area Annexed. The corporate limits of the City of Cleveland are hereby extended to include the land described as follows and the same is hereby annexed to and included within the City as if it had originally been a part thereof;

Beginning at a point on the North (N) line of the Northeast One Quarter (NE1/4) of the Southwest One Quarter (SW1/4) of Section Number 21, Township Number 110 North (N), Range Number 25 West (W), said point being 568.00 feet West (W) of the Center of said Section Number 21, thence continuing West (W) on said North (N) line 291.00 feet, thence South (S) 355.00 feet, thence East (E) 212.00 feet, thence North (N) 27 degrees 05 minutes East (E) 174.15 feet, thence North (N) 200.00 feet to the place of beginning.

Containing 2.00 acres and being part of the Northeast One Quarter (NE1/4) of the Southwest One Quarter (SW1/4) of said Section Number 21, Township Number 110 North (N), Range Number 25 West (W), Le Sueur County, Minnesota.

Section 3. Filing. The City Administrator is hereby directed to file certified copies of this ordinance with the Minnesota Municipal Boundary Adjustments Office, the Secretary of State, and the County Auditor.

Section 4. Effective Date of Annexation. This ordinance takes effect thirty days after its passage and publication and the filing of certified copies as directed in Section 3 and approval by the Minnesota Municipal Boundary Adjustments Office.






