## ORDINANCE NO. 263, THIRD SERIES AN ORDINANCE OF ANNEXATION BY THE CITY OF NORTH MANKATO, MINNESOTA, OF CERTAIN LAND TO-WIT: ALL THAT PART OF GOVERNMENT LOT 8 IN SECTION 36 TOWNSHIP 109 NORTH RANGE 27 WEST SEYKORA PROPERTY FOR ANNEXATION PURSUANT TO MINNESOTA STATUTES 414.033, SUBD. 2(3)

## THE CITY COUNCIL OF THE CITY OF NORTH MANKATO, MINNESOTA ORDAINS:

Section 1. The described tract of unincorporated property abuts the municipal limits of the City of North Mankato, Minnesota.

Section 2. The legal description of said land is as follows:

All that part of Government Lot 8 in Section 36 Township 109 North Range 27 West, Nicollet County, Minnesota all more particularly described as:

Commencing at the northwest corner of Government Lot 8 in said Section 36; thence North 89 degrees 47 minutes 13 seconds East (assumed bearing) along the north line of said Government Lot 8, a distance of 443.70 feet to the northwest corner of Outlot A, Leonard Diegnau Subdivision, according to the plat thereof on file and of record with the Nicollet County Recorder; thence South 01 degrees 34 minutes 49 seconds West, along the west line of said Outlot A, a distance of 486.95 feet to the point of beginning; thence North 88 degrees 20 minutes 19 seconds East, along the westerly line of said Outlot A, a distance of 404.65 feet; thence South 10 degrees 29 minutes 19 seconds West, along the westerly line of said Outlot A, a distance of 493.36 feet to the southwesterly corner of said Leonard Diegnau Subdivision; thence South 86 degrees 14 minutes 41 seconds East, along the southerly line of said subdivision, 154.30 feet; thence South 80 degrees 21 minutes 11 seconds East, along the southerly line of said subdivision, 67.00 feet; thence South 68 degrees 35 minutes 11 seconds East, along the southerly line of said subdivision, 70.00 feet; thence South 57 degrees 40 minutes 11 seconds East, along the southerly line of said subdivision, 50.00 feet; thence South 48 degrees 47 minutes 11 seconds East, along the southerly line of said subdivision, 100.95 feet to the most southeasterly corner of said Leonard Diegnau Subdivision; thence South 13 degrees 45 minutes 49 seconds West, along the southerly extension of the southeasterly line of said subdivision, 40.86 feet to a point on the former center line of Township Road No. 123 (Howard Drive), said point being on a circular curve which center of radius bears South 82 degrees 23 minutes 47 seconds West; thence southerly along said Township Road center line, along a 125.00 foot radius curve, central angle = 17 degrees 56 minutes 19 seconds, an arc distance of 39.14 feet to the point of tangency of said curve; thence South 10 degrees 20 minutes 06 seconds West, along the tangent of said curve, along the center line of said former Township Road, 121.52 feet to the point of curvature of a circular curve to the right; thence southerly along the former Township Road center line, along a 935.00 foot radius curve, central angle = 00 degrees 28 minutes 28 seconds, an arc distance of 7.74 feet to the point of intersection with the South line of the Southwest Quarter of Section 36; thence South 89 degrees 56 minutes 41 seconds West, along said south line, 921.94 feet to the northwest corner of Section 1 Township 108 North Range 27 West; thence South 89 degrees 57 minutes 35 seconds West, along the south line of the Southwest Quarter of Section 36, a distance of 195.19 feet to a found stone monument designating the southwest corner of Section 36; thence North 00 degrees 07 minutes 45 seconds East, along the west line of the Southwest Quarter of Section 36, the same being the west line of

Government Lot 8 in said Section 36, a distance of 411.00 feet to a point on the center line of the former Township Road No. 123; thence North 88 degrees 36 minutes 53 seconds East, along said center line, 233.00 feet; thence South 85 degrees 23 minutes 07 seconds East, along said former center line, 91.00 feet; thence South 80 degrees 04 minutes 23 seconds East, along said former center line, 107.74 feet; thence North 00 degrees 54 minutes 25 seconds West, 221.00 feet; thence North 01 degrees 34 minutes 49 seconds East, 208.73 feet to the point of beginning.

Said annexation parcel contains 13.35 acres, subject to any and all easements of record.

Section 3. Such land is now or is about to become urban or suburban in character.

Section 4. The land proposed for annexation is unplatted and contains 13.35 acres.

Section 5. The North Mankato City Council received petition dated April 26, 2005, bearing signatures of one hundred percent (100%) of the ownership interest in such land petitioned for annexation of the land to the City.

Section 6. Such land is hereby annexed to the City of North Mankato, Minnesota, and is declared to be included within its municipal limits.

Section 7. This ordinance shall be published once in the official newspaper of the City after adoption, signing and attestation and following this ordinance is approved by the Municipal Board of the State of Minnesota. The ordinance shall be in effect on and after the day following such publication and shall rescind the previous Ordinance of Annexation No. 256.
