AN ORDINANCE ANNEXING PROPERTY FROM SPRING LAKE TOWNSHIP INTO THE CITY OF PRIOR LAKE

The City Council of the City of Prior Lake does hereby ordain that:

1. That the following described property in Spring Lake Township is subject to annexation pursuant to Minnesota Statutes 414.033, Subdivision 2 (3);

That part of Government Lot 2, Section 10, Township 114, Range 22, Scott County, Minnesota, and that part of the Southwest Quarter of the Southeast Quarter of said Section 10, described as follows:

Beginning at a point on the west line of said Southwest Quarter of the Southeast Quarter distant 1176.65 feet northerly of the southwest corner; thence easterly parallel with the South line of said Southwest Quarter of the Southeast Quarter a distance of 818.53 feet; thence northerly parallel with the west line of the Southeast Quarter of said Section 10, distance of 372.78 feet; thence westerly parallel with said South line a distance of 818.53 feet to said west line; thence southerly along said west line a distance of 372.78 feet to the point of beginning.

AND

That part of Government Lot 2, Section 10, Township 114, Range 22, Scott County, Minnesota and that part of the Southwest Quarter of the Southeast Quarter of said Section 10, described as follows:

Beginning at a point on the west line of said Southwest Quarter of the Southeast Quarter distant 1176.65 feet Northerly of the Southwest corner, thence Easterly parallel with the South line of said Southwest Quarter of the Southeast Quarter a distance of 818.53 feet; thence Northerly parallel with the west line of the Southeast Quarter of said Section 10, a distance of 1451.0 feet more or less to the North line of said Government Lot 2; thence Westerly along said North line to Northwest corner; thence Southerly along the west line of said Government Lot 2, and the west line of the Southeast Quarter of Southeast Quarter of Southeast Quarter to the point of beginning. All being in Scott County, Minnesota.

2. The petition for annexation has been signed by all of the owners of the subject property; and
