The evidentiary hearing concerning this Petition will reconvene on Monday, March 24, 2008, beginning at 9:00 a.m. in Wyoming City Hall, 26885 Forest Boulevard, Wyoming, Minnesota. The hearing will be before Administrative Law Judge Steve Mihalchick. This is a continuation of a hearing originally held on February 23, 2006.

The only formal parties to this proceeding are the Petitioner, the City of Chisago City; Attorney for the City of Chisago City, Christopher Hood; the City of Wyoming; Wyoming Township; and Attorney for the City of Wyoming and Wyoming Township, Tim Sime. The City has petitioned the State for authority to annex certain land.

The hearing will be conducted pursuant to the procedure set out in Minn. Rules, Chapter 6000 as supplemented by Minnesota Rules 14.57 - 14.62. On December 29, 2007, the City of Chisago City filed a Motion for Order Amending

Annexation Resolution to include additional land described as follows:

All of the West-half of Section 3 in Township 33 North, Range 21 West, Chisago County, Minnesota.

And also all of Section 4 in Township 33 North, Range 21 West, Chisago County, Minnesota.

The Administrative Law Judge granted the motion.

The total area that Chisago City now seeks to annex, pursuant to its Amended Annexation Resolution, is described as follows:

All of the East-half of Sections 15, 22, and 27, in Township 33 North, Range 21 West, Chisago County, Minnesota.

And also all of that part of Section 10 in Township 33 North, Range 21 West, Chisago County, Minnesota, except the City of Wyoming, Chisago County, Minnesota.

And also all of the East-half, all of the Southwest Quarter, and all of the Northwest Quarter located south and east of U.S. Highway 8, all in Section 34, in Township 33 North, Range 21 West, Chisago County, Minnesota.

And also all of Sections 3, 4, 35 and 36, in Township 33 North, Range 21 West, Chisago County, Minnesota.

**On the evening of Wednesday, March 26, 2008, beginning at 6:00 p.m., in the Wyoming City Hall, there will be a public hearing for purpose of public comment. Any person interested in this matter will be given an opportunity to present oral statements and to submit written data, statements, or arguments on Wednesday evening.**

Following the close of the hearing, the Administrative Law Judge will issue a written final decision pursuant to Minnesota Statutes, Chapter 414 and the March 9, 2006 referral from the Director of Municipal Boundary Adjustments.


