The evidentiary hearing concerning this Petition will reconvene on Monday, March 24, 2008, beginning at 9:00 a.m. in Wyoming City Hall, 26885 Forest Boulevard, Wyoming, Minnesota. The hearing will be before Administrative Law Judge Steve Mihalchick. This is a continuation of a hearing originally held on February 23, 2006.

The only formal parties to this proceeding are the Petitioner, the City of Stacy; Attorney for the City of Stacy, George Hoff; the City of Wyoming; Wyoming Township; and Attorney for the City of Wyoming and Wyoming Township, Tim Sime. The City has petitioned the State for authority to annex certain land.

The hearing will be conducted pursuant to the procedure set out in Minn. Rules, Chapter 6000 as supplemented by Minnesota Rules 14.57 - 14.62. The property proposed for annexation is described as follows:

All of the Northwest Quarter, the Northeast Quarter, the Southeast Quarter and that part of the Southwest Quarter lying east of the easterly right of way line of Interstate Highway

No. 35, all in Section 5, Township 33 North, Range 21 West, Chisago County, Minnesota. Together with: All of the Northeast Quarter, that part of the Northwest Quarter lying east of the easterly right of way line of Interstate Highway No. 35 and that part of the Southwest Quarter lying within the plat of Miller Estates First Addition, a plat that is on file and of record in the office of the County Recorder, Chisago County, Minnesota, all in Section 8, Township 33 North, Range 21 West, Chisago County, Minnesota.

**On the evening of Wednesday, March 26, 2008, beginning at 6:00 p.m., in the Wyoming City Hall, there will be a public hearing for purpose of public comment. Any person interested in this matter will be given an opportunity to present oral statements and to submit written data, statements, or arguments on Wednesday evening.**


