ORDINANCE NO. <u>566</u>, SECOND SERIES

AN ORDINANCE OF THE CITY OF MARSHALL ANNEXING LAND LOCATED IN THE TOWN OF LAKE MARSHALL, LYON COUNTY, MINNESOTA TO THE CITY OF MARSHALL, LYON COUNTY, MINNESOTA, PURSUANT TO MINNESOTA STATUTES, SECTION 414.033, SUBDIVISION 2(3), PERMITTING ANNEXATION BY ORDINANCE

THE CITY OF MARSHALL DOES HEREBY ORDAIN:

Section 1. That the unincorporated land legally described in <u>Exhibit A</u>, which is attached hereto and incorporated herein by reference, located in the Town Lake Marshall, Lyon County, Minnesota, is land that is contiguous to and abuts the municipal corporate limits of the City of Marshall, Lyon County, Minnesota; is land that is 120 acres or less in size; is land that is not presently served by public sewer facilities, and for which public sewer facilities are not otherwise available than through the City of Marshall; and is land that is existing or proposed for immediate urban or suburban development.

Section 2. That the property-owner of the property legally described in <u>Exhibit A</u> has requested annexation for purposes of immediately developing the land for additional urban or suburban commercial uses needing municipal services, and has submitted a petition to the City Council of the City of Marshall for annexation of said land.

Section 3. That the City of Marshall held a public hearing pursuant to Minnesota Statutes, Section 414.033, Subdivision 2b, on January 29, 2007, following thirty (30) days written notice by certified mail to the Town of Lake Marshall and to all landowners within and contiguous to the area, legally described in <u>Exhibit A</u>, to be annexed.

Section 4. That the corporate limits of the City of Marshall are hereby extended to include the land legally described in <u>Exhibit A</u>, and shown on the map attached hereto and incorporated herein by reference as <u>Exhibit B</u>, containing 60.02 acres, and the same is hereby annexed to be included within the City of Marshall, Lyon County, Minnesota.

Section 5. That the population of the area legally described in <u>Exhibit A</u>, and hereby annexed, is 0.

Section 6. The City of Marshall and the Town of Lake Marshall have agreed, pursuant to Minnesota Statutes, Section 414.036, that with respect the property taxes payable on the area legally described in <u>Exhibit A</u>, hereby annexed, the City of Marshall shall make a cash payment to the Town of Lake Marshall for the period and in accordance with the following schedule:

- a. In the first year following the year the City of Marshall could first levy on the annexed area, an amount equal to \$44.02; and
- b. In the second and final year, an amount equal to \$44.02.

Section 7. That pursuant to Minnesota Statutes, Section 414.036 with respect to any special assessments assigned by the Township to the annexed property and any portion of debt incurred by the Township prior to the annexation and attributable to the property to be annexed, but for which no special assessments are outstanding, for the area legally described in <u>Exhibit A</u>, there are no special assessments or debt incurred by the Township on the subject area for which reimbursement is required.

Section 8. That the Finance Director/City Clerk of the City of Marshall is hereby authorized and directed to file a copy of this Ordinance with the Minnesota Office of Administrative Hearings Municipal Boundary Adjustments Office, the Minnesota Secretary of State, the Lyon County Auditor, and the Lake Marshall Township Clerk.

Section 9. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Minnesota Office of Administrative Hearings.

EXHIBIT A Legal Description

All that part of the West Half of the Southeast Quarter of Section 10, Township 111 North, Range 41 West, Lyon County, Minnesota, being more particularly described as follows:

Beginning at the northwest corner of said Southeast Quarter; thence North 89 degrees 44 minutes 53 seconds East, bearing based on Minnesota State Plane Coordinate System Lyon County Datum, along the north line of said Southeast Quarter, a distance of 987.30 feet; thence South 00 degrees 37 minutes 25 seconds East a distance of 2648.72 feet to a point on the south line of said Southeast Quarter; thence South 89 degrees 48 minutes 15 seconds West, along said south line, a distance of 987.30 feet to the southwest corner of said Southeast Quarter; thence North 00 degrees 37 minutes 25 seconds West, along the west line of said Southeast Quarter, a distance of 2647.75 feet to the point of beginning.




EXHIBIT B Boundary Map
