#### ORDINANCE NO. 2008-8

### AN ORDINANCE OF THE CITY OF MOORHEAD ANNEXING LAND LOCATED IN THE TOWN OF MOORHEAD, CLAY COUNTY, MINNESOTA TO THE CITY OF MOORHEAD, CLAY COUNTY, MINNESOTA, PURSUANT TO MINN. STAT. § 414.033, SUBD. 2(3), PERMITTING ANNEXATION BY ORDINANCE

WHEREAS, the City of Moorhead has received a petition for annexation from all landowners of the property to be annexed; and

WHEREAS, under state law the landowner has the right to request annexation into the City of Moorhead, and the City of Moorhead has authority to annex such property; and

WHEREAS, under the law of the State of Minnesota cities have no authority outside the provisions of Chapter 414 to regulate annexation of land in Minnesota; and

NOW THEREFORE THE CITY OF MOORHEAD DOES HEREBY ORDAIN:

Section 1. That the unincorporated land legally described in <u>Exhibit A</u>, which is attached hereto and incorporated herein by reference, located in the Town of Moorhead, Clay County, Minnesota, is land that is contiguous to and abuts the municipal corporate limits of the City of Moorhead, Clay County, Minnesota; is land that is 120 acres or less in size; is land that is not presently served by public wastewater facilities, and for which public wastewater facilities are not otherwise available than through the City of Moorhead; and is land that is existing or proposed for immediate urban or suburban development.

**Section 2.** That the property-owner of the property legally described in <u>Exhibit A</u> has requested annexation for purposes of immediately redeveloping the land for additional urban or suburban commercial uses and has submitted a petition to the City Council of the City of Moorhead for annexation of said land.

**Section 3.** That the City of Moorhead has, or will, hold a public hearing pursuant to Minn. Stat. § 414.033, subd. 2b, on February 19, 2008, following thirty (30) days written notice by certified mail to the Town of Moorhead and to all landowners within and contiguous to the area, legally described in <u>Exhibit A</u>, to be annexed.

**Section 4**. That the corporate limits of the City of Moorhead are hereby extended to include the land legally described in <u>Exhibit A</u>, and shown on the map attached hereto and incorporated herein by reference as <u>Exhibit B</u>, containing approximately 0.5 acres, and the same is hereby annexed to be included within the City of Moorhead, Clay County, Minnesota.

**Section 5.** That the population of the area legally described in <u>Exhibit A</u>, and hereby annexed is 0.

**Section 6.** That with respect to the property taxes payable on the area legally described in <u>Exhibit A</u>, hereby annexed, the City of Moorhead shall make a cash payment to the Town of Moorhead for the period and in accordance with the following schedule:

- a. In the first year following the year the City of Moorhead could first levy on the annexed area, an amount equal to \$112.72.
- b. In the second year, an amount equal to \$112.72.

**Section 7**. That the City Manager of the City of Moorhead is hereby authorized and directed to file a copy of this Ordinance with the Minnesota Office of Administrative Hearings Municipal Boundary Adjustments Office, the Minnesota Secretary of State, the Clay County Auditor, and the Moorhead Township Clerk.

**Section 8**. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Minnesota Office of Administrative Hearings.

### EXHIBIT A Legal Description

The Subject Area to be annexed in the attached Ordinance is described as follows:
