### ORDINANCE NO.

# AN ORDINANCE ANNEXING PROPERTY LOCATED IN SECTION 36, TOWNSHIP 125, RANGE 39, WEST TO THE CORPORATE LIMITS OF THE CITY OF STARBUCK

WHEREAS, a majority (100%) of the property owners of the lands described below have petitioned the Starbuck City Council to annex this territory to the City of Starbuck, pursuant to Minnesota Statutes Section 414.033, Subdivision 5, and

WHEREAS, the property abuts upon the southerly boundaries of the Starbuck City Limits along the northerly boundaries of the subject property, and

WHEREAS, the property is not presently part of any incorporated city, and

WHEREAS, the property consists of both platted and unplatted land in White Bear Lake Township, Pope County, containing approximately 1.47 acres in five (5) parcels owned by four (4) property owners, and

WHEREAS, the Starbuck City Council finds that the property is suburban in character by surrounding development and usage and is not currently served by municipal water services, and

WHEREAS, the existing and proposed uses of the subject property are residential in nature, and

WHEREAS, the City of Starbuck has received a Waiver of Objection to Annexation Petition from White Bear Lake Township,

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF STARBUCK HEREBY ORDAINS:

**SECTION I:** That the Corporate Limits of the City of Starbuck are hereby extended to include land as described and the same is hereby annexed and included within the City.

SECTION II: That the territory to be annexed is described as:

SECTION III: That the lands hereby annexed are to be zoned as Residential.

- **SECTION VI:** This Ordinance shall be in full force and effect from and after its passage, publication and approval by the State of Minnesota.

- Parcel 1: Lots 45, 46, and 47, Tharaldson's First Subdivision of Government Lots 3 and 4, Section 36, Township 125 N, Range 39 W, Pope County, Minnesota.


