Being that the property is owned by the city and used for road and right of way purposes, it has been classified as tax exempt by the Olmsted County Assessor prior to the adoption of this ordinance. Based on the existing tax exempt status, the city will not be responsible for continued tax payments to Kalmar Township.

Section 9. That Byron's City Clerk is directed to file a certified copy of this Ordinance with the following boards and agencies: Office of Administrative Hearings, Mantorville Township, Dodge County Auditor and the Minnesota Secretary of State.






