## CITY OF PINE ISLAND ORDINANCE NO. 108 2<sup>ND</sup> SERIES.

## AN ORDINANCE ANNEXING CERTAIN LANDS LYING WITHIN NEW HAVEN TOWNSHIP

## THE CITY OF PINE ISLAND DOES ORDAIN:

- Section 1. The owners of the property located in New Haven Township, Olmsted County, Minnesota described in Exhibit A attached hereto have requested annexation of such property into the corporate limits of the City of Pine Island.
- Section 2. The land is deemed to be urban or suburban in character or about to become so and contains a residential farmstead to be used for such purpose.
  - Section 3. The land is not currently served by public wastewater facilities.
- Section 4. The City provided thirty (30) days written notice, by certified mail, to New Haven Township and all owners of the land contiguous thereto of a public hearing on April 19, 2011 at 7:00 p.m., at City Hall concerning the annexation.
- Section 5. Pursuant to Minnesota Statute 414.033, the City hereby annexes the properties described in Exhibits A into the City. The City hereby directs that the zoning map referenced in the Pine Island City Code be amended to include such property.
- Section 6. The City Administrator is directed to promptly file a copy of this Ordinance with the Office of Administrative Hearings, the New Haven Township clerk, the Olmsted County Auditor and the Minnesota Secretary of State.
- Section 7. The City will share 50% of tax proceeds for the 2 years following approval of this annexation with New Haven Township.
- Section 8. This Ordinance is effective immediately and the annexation is final on the date of approval by the Office of Administrative Hearings. This Ordinance shall be added to Chapter 20 (Listing of Uncoded Ordinances in Effect) of the Pine Island City Code.






