PETITIONER(S) STATE: The undersigned, the sole owners of the property described below, hereby requests that the Cottonwood City Council annex this property to the City of Cottonwood and to extend the City boundaries to include the same, and for that purpose respectfully state:

It is hereby requested by all of the property owners (Terry and Linda Dieken) of the area proposed for annexation to annex certain property described herein lying in the Township of Lucas to the City of Cottonwood, County of Lyon, Minnesota.

The area proposed for annexation is described as follows:

All that part of Government Lot 4 of Section 4, Township 113 North, Range 40 West, Lyon County, Minnesota, being more particularly followed as:

Beginning at the northerly corner of Northwood Drive as shown on the plat of Northwood First Addition, in the City of Cottonwood, as filed and recorded in the office of the County Recorder in and for said Lyon County; thence South 64 degrees 23 minutes 10 seconds West, bearing based on Lyon County Coordinate System, along the northwesterly line of said Northwood First Addition, a distance of 338 feet, more or less, the northwesterly corner of Lot 7 Block 2 Northwood First Addition; thence beginning again at said point of beginning; thence North 25 degrees 36 minutes 50 seconds West, along the northwesterly extension of said Northwood Drive, a distance of 166.63 feet to a point on the north line of said Government Lot 4; thence South 89 degrees 18 minutes 15 seconds West, along said north line, a distance of 320 feet, more or less, to the northwesterly corner of said Lot 7, said description there terminating.

- 1. There are two property owners (Terry and Linda Dieken) in the area proposed for annexation.
- 2. Both property owners have signed this petition.
- 3. Said property is unincorporated, abuts on the city's northern boundary, and is not included within any other municipality.
- 4. The area of land proposed for annexation, in acres, is: 1.45 Acres Platted (Pending public hearing for plat on 6/7/2011)

- 5. The reason for the requested annexation is the property will be developed and extension of city services to the property will be required.
- 6. The area proposed for annexation will be zoned R-1 (Single Family Residential).
- 7. All of the area proposed for annexation is or is about to become urban or suburban in character.
- 8. The area proposed for annexation is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes § 414.0325, nor in any other boundary adjustment proceeding pending before the Office of Administrative Hearings Municipal Boundary Adjustments.




