

**ORDINANCE NO. 155****An Ordinance Extending the Corporate Limits of the City of Moose Lake to Include Certain Unincorporated, Unplatted Territory Abutting the City Limits and Owned by the City**

The City Council of the City of Moose Lake, Minnesota hereby ordains:

Section 1. The Council hereby determines that annexation of land now owned by the City and intended for, or now used for, city utility purposes, namely waste-water treatment ponds or expansion, is in the best interests of the City and the territory to be annexed; that the said city owned lands about the current corporate limits and are urban or suburban in character or about to become so; and, that none of said city owned lands are now included within the limits of any other city, village or borough.

Section 2. Territory Annexed. The corporate limits of the City of Moose Lake are hereby extended to include the unplatted land described as follows, and the same are hereby annexed to and include within the City as effectively as if said lands had originally been a part thereof:

**Parcel One.** South Half of Southwest Quarter ( $S\frac{1}{2}$  of  $SW\frac{1}{4}$ ) of Section Thirty (30), Township Forty-six (46) North of Range Nineteen (19) West, Carlton County, Minnesota, lying Westerly of the Northwestern right of way line of Soo Line Railroad (now abandoned), formerly the Minneapolis, Sault Ste. Marie Railway Company, and lying Northerly of the South 175 feet thereof.  
Tax Parcel No. 63-022-3405. Moose Lake Township.

**Parcel Two.** That part of the Northeast Quarter of Southeast Quarter ( $NE\frac{1}{4}$  of  $SE\frac{1}{4}$ ) of Section Twenty-five (25), Township Forty (46) North of Range Twenty (20) West, of the Fourth Principal Meridian, Carlton County, Minnesota, lying Southeasterly of the following described line: Commencing at the Northeast corner of said Southeast Quarter ( $SE\frac{1}{4}$ ) of Section 25; thence West, assumed bearing, 590.00 feet along the North line of said  $SE\frac{1}{4}$  of Section 25 to the beginning of the line to be described; thence South  $35^{\circ}45'00''$  West to a point on the South line of the North Half ( $N\frac{1}{2}$ ) of said  $SE\frac{1}{4}$  of Section 25 and said line there terminating.

TOGETHER WITH a permanent easement for sewer pond purposes over and across that part of the Northwest Quarter of Southeast Quarter ( $NW\frac{1}{4}$  of  $SE\frac{1}{4}$ ) of Section Twenty-five (25), Township Forty-six (46) North, of Range Twenty (20) West, of the Fourth Principal Meridian, Carlton County, Minnesota, lying Southeasterly of the following described line: Commencing at the Northeast corner of said Southeast Quarter ( $SE\frac{1}{4}$ ) of Section 25; thence West, assumed bearing assumed bearing, 590.00 feet along the North line of said  $SE\frac{1}{4}$  of Section 25 to the beginning of the line to be described; thence South  $35^{\circ}45'00''$  West to a

point on the South line of the North Half (N½) of said SE¼ of Section 25 and said line there terminating.

Tax Parcel No. 66-016-4320. Silver Township.

**Parcel Three.** The North 900.00 feet of the East 1,934.00 feet of the South Half of the Southeast Quarter, Section 25, Township 46, North of Range 20 West of the Fourth Principal Meridian, Carlton County, Minnesota.



Section 4. This Ordinance shall effect upon its passage, publication and approval by the chief administrative law judge.


