ORDINANCE NO. 2013-01

CITY OF BIG LAKE SHERBURNE COUNTY, MINNESOTA

AN ORDINANCE ANNEXING LAND PURSUANT TO MINNESOTA STATUTES SECTION 414.033, SUBDIVISION 2(1) PERMITTING ANNEXATION BY ORDINANCE

WHEREAS, the City of Big Lake is fee owner of certain property legally described in the attached Exhibit "A";

WHEREAS, the Subject Property is not presently within the corporate limits of any incorporated city; and

WHEREAS, the Subject Property abuts upon the city limits; and

WHEREAS, Minnesota Statute § 414.033, subd. 2(1) authorizes annexation by ordinance if the land is owned by the City.

THE CITY COUNCIL OF THE CITY OF BIG LAKE, MINNESOTA ORDAINS:

SECTION 1. SUBJECT PROPERTY ANNEXED. The corporate limits of the City of Big Lake are hereby extended to include the real property legally described in the attached Exhibit "A" now owned by City, and the same is hereby annexed to and included within the City as effectually as if it had originally been part of the City.

SECTION 2. CITY REIMBURSEMENT TO TOWN. Minnesota Statute § 414.036 states that unless otherwise agreed to by the annexing municipality and the affected town, when an order or other approval under this chapter annexes part of a town to a municipality, the order or other approval must provide a reimbursement from the municipality to the town for all or part of the taxable property annexed as part of the order. The Township of Big Lake and City of Big Lake have agreed to \$0.00 reimbursement. See Exhibit "B" for letter from Township.

SECTION 3. FILING. The City Clerk is directed to file certified copies of this ordinance with the Minnesota Secretary of State, the Sherburne County Auditor, the Big Lake Township Clerk, and the Municipal Boundary Adjustment unit of the Minnesota Office of Administrative Hearings.

SECTION 4. EFFECTIVE DATE OF ANNEXATION. This ordinance takes effect upon its passage and publication and the filing of certified copies as directed in Section 3, and approval of this Ordinance by the State of Minnesota (State Municipal Boundary Adjustment unit).


