## **ORDINANCE NO. 663**

An Ordinance Repealing Ordinance No. 656 and Adopting an Ordinance of the City of Cambridge, Minnesota

Annexing Land Located in Cambridge Township, Isanti County, Minnesota Pursuant to Minnesota Statutes § 414.033 Subdivision 2 (3), Permitting Annexation by Ordinance

WHEREAS, said property is unincorporated, abuts the corporate boundaries of the City of Cambridge, is less than 120 acres; and

WHEREAS, the City of Cambridge received a petition for annexation from all the property owners of the land; and

WHEREAS, the Planning Commission reviewed the ordinance at its November 7, 2017 meeting; and

WHEREAS, the City of Cambridge gave proper prior notice to Cambridge Township and contiguous property owners and held a public hearing pursuant to Minnesota Statutes § 414.033 subd. 2b on December 4, 2017.

**NOW, THEREFORE,** THE CITY COUNCIL OF THE CITY OF CAMBRIDGE HEREBY ORDAINS AS FOLLOWS:

- The City Council hereby determines that the property as hereinafter described is less than 120 acres, is not presently served by public wastewater facilities and the municipality received a petition from the property owners of the land.
- 2. None of the property is now included within the limits of any city, or in any area that has already been designated for orderly annexation pursuant to Minnesota Statute § 414.0325.
- 3. The corporate limits of the City of Cambridge, Minnesota, are hereby extended to include the property described below (and in Exhibit A):

PARCEL 1 - PID 03.031.2400 - 726 Highway 95 NE

That part of the North Half of Northeast Quarter (N ½ of NE ¼) of Section Thirty-one (31), Township Thirty-six (36), Range Twenty-three (23), described as follows, to wit: Commencing on the North line of Section 31, Township 36, Range 23; said point of commencement 1447.5 feet West of the Northeast corner of said Section 31; thence south and parallel with the East line of said Section 31, a distance of 343 feet; thence West a distance of 190 feet; thence North and parallel with the East line of said Section 31, a distance of 343 feet and to the North line of said Section 31; thence East on the Section line 190 feet to the point of beginning.

PARCEL 2 - PID 03.031.0300 - 740 Highway 95 NE

That part of the North Half of Northeast Quarter (N ½ of NE ¼) of Section Thirty-one (31), Township Thirty-six (36), Range Twenty-three (23), described as follows, to wit: Commencing on the North line of Section 31, Township 36, Range 23; said point of commencement 1127.5 feet West of the Northeast corner of said Section 31; thence South and parallel with the East line of said Section 31, a distance of 343 feet; thence West a distance of 320 feet; thence North and parallel with the East line of said Section 31, a distance of 343 feet and to the North line of said Section 31, thence East on the Section line 320 feet to the point of beginning.

- 4. That the area legally described herein is currently vacant and will not increase the population of Cambridge at this time.
- 5. That pursuant to Minnesota Statutes § 414.036 there are no special assessments assigned by the Town to the annexed property and the City of Cambridge shall pay to Cambridge Township a reimbursement of \$18.60 (50% of the township taxes for 03.031.2400 & 03.031.0300) on July 1 in the years of 2019, 2020, as is required by Minnesota Statutes § 414.036.
- 6. That the cost of electric utility service will not change upon annexation as indicated by the electric company pursuant to Minn. Stat. § 414.033, Subd. 13.
- 7. That the City Administrator of the City of Cambridge is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, the Isanti County Auditor, and the Cambridge Township Clerk.
- 8. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Office of Administrative Hearings.




