ORDINANCE NO. 2019-040

AN ORDINANCE OF THE CITY OF WILTON, MINNESOTA ANNEXING LAND LOCATED IN ECKLES TOWNSHIP, BELTRAMI COUNTY, MINNESOTA PURSUANT TO MINNESOTA STATUTES § 414.033 SUBDIVISION 2(3), PERMITTING ANNEXATION BY ORDINANCE

WHEREAS, a petition signed by all the property owners, requesting that property legally described herein be annexed to the City of Wilton Minnesota, was duly presented to the Council of the City of Wilton, on the,1st day of October, 2019; and

WHEREAS, said property is unincorporated and abuts the City of Wilton, on its Northern boundary; is less than 120 acres; is not presently served by public sewer facilities or public sewer facilities are not otherwise available; and

WHEREAS, said property is located within a shoreland area; Any New development of annexed area shall be subject to chapter 103F Minnesota Statutes § 414.033 Subd. 11., and City of Wilton Ordinance No. 24A, Appendix V, to City of Wilton Ordinance No. 24, Zoning, Shoreland Management; and

WHEREAS, said property is currently Rural Vacant / Residential and annexation is requested to facilitate the extension of city services for the residential/urban/commercial/industrial development of the property; and

WHEREAS, the City of Wilton held a public hearing pursuant to Minnesota Statutes § 414.033 Subd. 2b, on the 4th day of November, 2019, following thirty (30) days written notice by certified mail to the Town of Eckles, and to all landowners within and contiguous to the area legally described herein to be annexed; and

WHEREAS, provisions of Minnesota Statutes § 414.033 Subd. 13 are not applicable in that there will be no change in the electric utility service provider resulting from the annexation of the territory to the municipality.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WILTON, MINNESOTA HEREBY ORDAINS AS FOLLOWS:

1. The City Council hereby determines that the property as hereinafter described abuts the city limits and is or is about to become urban or suburban in nature in that residential / urban / commercial / industrial development use is being proposed for said property the construction of which requires or will need city services, including public sewer facilities.

2. None of the property is now included within the limits of any city, or in any area that has already been designated for orderly annexation pursuant to Minnesota Statute § 414.0325.

3. The corporate limits of the City of Wilton, Minnesota, are hereby extended to include the following described property, said land abutting the City of Wilton, and being 120 acres or less in area, and is not presently served by public sewer facilities or public sewer facilities are not otherwise available, and the City having received a petition for annexation from all the property owners of the land, to wit:

Parcel Number: 12.00377.01; The south 461.00 feet of the West Half of the Southeast Quarter (W 1/2 of SE 1/4) of section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty four (34), lying northerly of U.S. Highway Number 2, less the East 33.00 feet of the South 461.00 feet of said W1/2 of SE1/4.

Parcel Number: 12.00374.00; The Southeast Quarter of the Southwest Quarter (SE1/4 SW1/4) less the West 330 feet; Section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty-four (34), lying northerly of U.S. Highway Number 2.

Parcel Number: 12.00377.02; The North 480.00 feet of the South 941.00 feet of the West Half of the Southeast Quarter (W1/2 of SE1/4) of Section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty-four, (34); AND The East 33.00 feet of the South 461.00 feet of said W1/2 of said SE1/4.

Parcel Number: 12.00377.00;The West Half of the Southeast Quarter (W1/2 of SE1/4) less the South 941.00 feet; Section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty-four (34).

The above described property consists of a total of 101.08 acres, more or less. Copies of the corporate boundary map showing the property to be annexed and its relationship to the corporate boundaries and all appropriate plat maps are attached hereto.

4. That the population of the area legally described (herein or attached exhibit) and hereby annexed is 2.

5. The City of Wilton, pursuant to Minnesota Statutes § 414.036, that with respect to the property taxes payable on the area legally described herein, hereby annexed, shall make a cash payment to the Town of Eckles in accordance with the following schedule:

OPTION A:

- a. In the first year following the year in which the City of Wilton could first levy on the annexed area, an amount equal to \$231.92; and
- b. In the second and final year, an amount equal to \$231.92.

6. That pursuant to Minnesota Statutes § 414.036 with respect to any special assessments assigned by the Town to the annexed property and any portion of debt incurred by the Town prior to the annexation and attributable to the property to be annexed, but for which no special assessments are outstanding, for the area legally described herein, there are no special assessments or debt incurred by the Town on the subject are for which reimbursement is required.

7. That the City Clerk of the City of Wilton, is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, the Beltrami County Auditor, and the Eckles Township Clerk.

8. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Office of Administrative Hearings.
