In the Matter of the Annexation of Certain  
Real Property to the City of Wilton from  
Eckles Township (MBAU Docket A-8234)

**ORDER APPROVING  
ANNEXATION ORDINANCE**

On November 4, 2019, the City of Wilton (City) adopted Ordinance Number 2019-040 (Ordinance) annexing certain real property (Property) from Eckles Township legally described as follows:

Parcel Number 12.00377.01

The South 461.00 feet of the West Half of the Southeast Quarter ( $W\frac{1}{2}$  of  $SE\frac{1}{4}$ ) of section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty-four (34), lying northerly of U.S. Highway Number 2, less the East 33.00 feet of the South 461.00 feet of said  $W\frac{1}{2}$  of  $SE\frac{1}{4}$ .

Parcel Number 12.00374.00

The Southeast Quarter of the Southwest Quarter ( $SE\frac{1}{4}$   $SW\frac{1}{4}$ ) less the West 330 feet; Section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty-four (34), lying northerly of U.S. Highway Number 2.

Parcel Number 12.00377.02

The North 480.00 feet of the South 941.00 feet of the West Half of the Southeast Quarter ( $W\frac{1}{2}$  of  $SE\frac{1}{4}$ ) of Section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty-four, (34); and the East 33.00 feet of the South 461.00 feet of said  $W\frac{1}{2}$  of  $SE\frac{1}{4}$ .

Parcel Number 12.00377.00

The West Half of the Southeast Quarter ( $W\frac{1}{2}$  of  $SE\frac{1}{4}$ ) less the South 941.00 feet; Section Twenty-nine (29), Township One Hundred Forty-seven (147), Range Thirty-four (34).

Based upon a review of the Ordinance, the Administrative Law Judge makes the following:

**ORDER**


1. Pursuant to Minn. Stat. § 414.033 (2018), the Ordinance is deemed adequate in all legal respects and properly supports this Order.

2. Pursuant to the terms of the Ordinance and this Order, the Property is **ANNEXED** to the City.

3. Pursuant to Minn. Stat. § 414.036 (2018), the City will reimburse the Township \$231.92 each year for two years as stated in Ordinance No. 2019-040.

4. The City must file a copy of the Annexation Ordinance with the Township, the appropriate county auditor, and the Secretary of State as required by Minn. Stat. § 414.033, subd. 7.
