ORDINANCE NO. 153.03 - 2020

AN ORDINANCE OF THE CITY OF WATERVILLE, MINNESOTA ANNEXING LAND LOCATED IN WATERVILLE TOWNSHIP, LE SUEUR COUNTY, MINNESOTA PURSUANT TO MINNESOTA STATUTES § 414.033 SUBDIVISION 2(1), PERMITTING ANNEXATION BY ORDINANCE

WHEREAS, the City of Waterville owns Parcel Identification No. 14.999.0130 located in Le Sueur County, Minnesota, legally described on Attached Exhibit A, and depicted by map on attached Exhibits B; and

WHEREAS, said property is not incorporated into the City's Corporate Limits and contains the City's Wastewater Treatment Plant, and

WHEREAS, said property is entirely owned in fee by the City of Waterville; and

WHEREAS, the City of Waterville held a public hearing pursuant on this annexation on this date after duly noticing the same; and

WHEREAS, provisions of Minnesota Statutes § 414.033 Subd. 13 are not applicable in that there will be no change in the electric utility service provider resulting from the annexation of the territory to the municipality.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WATERVILLE HEREBY ORDAINS AS FOLLOWS:

- 1. The corporate limits of the City of Waterville, Minnesota, are hereby extended to include the property described on Attached Exhibit A, and as depicted by map on attached Exhibits B.
- 2. That the City Clerk of the City of Waterville is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, the Le Sueur County Auditor, and the Waterville Township Clerk.
- 3. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Office of Administrative Hearings.


