

### ORDINANCE NO. 2020-14

# AN ORDINANCE OF THE CITY OF MOORHEAD ANNEXING LAND LOCATED IN CLAY COUNTY, MINNESOTA, TO THE CITY OF MOORHEAD, CLAY COUNTY, MINNESOTA, PURSUANT TO MINN. STAT. § 414.033, SUBD. 2(3) PERMITTING ANNEXATION BY ORDINANCE.

WHEREAS, the City of Moorhead has received a petition for annexation from all landowners of the property to be annexed; and

WHEREAS, under state law, the landowner has the right to request annexation into the City of Moorhead, and the City of Moorhead has authority to annex such property.

## NOW, THEREFORE, THE CITY OF MOORHEAD DOES HEREBY ORDAIN

Section 1. That the unincorporated land legally described in <u>Exhibit A</u>, which is attached hereto and incorporated herein by reference, located in Moorhead Township, Clay County, Minnesota, is land that abuts the municipal corporate limits of the City of Moorhead, Clay County, Minnesota (the "Property"); the land to be annexed is 120 acres or less, and the area to be annexed is not presently served by public wastewater facilities or public wastewater facilities are not otherwise available, and the municipality received a petition for annexation from all the property owners of the land.

Section 2. That the landowner of the Property and the City of Moorhead previously entered into a 46<sup>th</sup> Avenue South Access and Annexation Agreement dated May 16, 2019, wherein the landowner was granted access to the Property to accommodate construction of a proposed project of self-service storage units; and the parties agreed that the landowner was to petition for the Property to become part of the City within one (1) year of receiving a certificate of occupancy for the first available structure.

Section 3. That the City of Moorhead held a public hearing pursuant to Minn. Stat. § 414.033, subd. 2b, on January 11, 2021, following thirty (30) days' written notice by certified mail to Moorhead Township and to all landowners within and contiguous to the area, legally described in Exhibit A, to be annexed.

Section 4. That the corporate limits of the City of Moorhead are hereby extended to include the land legally described in <u>Exhibit A</u>, containing approximately 6.3 acres, and the same is hereby annexed to be included within the City of Moorhead, Clay County, Minnesota.

Section 5. That the population of the area legally described in <u>Exhibit A</u>, and hereby annexed is 0.

Section 6. That with respect to the property taxes payable on the area legally described in <u>Exhibit A</u>, hereby annexed, the City of Moorhead shall make a cash payment to Moorhead Township in an amount equal to Moorhead Township's lost revenue for the period of one year (\$178.00 based on the 2020 tax statement), as follows:

- a. In the first year following the year the City of Moorhead could first levy on the annexed area, a payment of \$89.00 will be made to Moorhead Township.
- b. In the second year following the year the City of Moorhead could first levy on the annexed area, a payment of \$89.00 will be made to Moorhead Township.

Section 7. That the City Manager of the City of Moorhead is hereby authorized and

directed to file a copy of this Ordinance with the Minnesota Office of Administrative Hearings Municipal Boundary Adjustments Office, the Minnesota Secretary of State, the Clay County Auditor, and the Moorhead Township Clerk.

Section 8. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Minnesota Office of Administrative Hearings.

This Ordinance shall take effect upon publication in accordance with Moorhead City Charter.

#### EXHIBIT A Legal Description of the Property




