

ORDINANCE NO. 739

An Ordinance of the City of Cambridge, Minnesota

Annexing Land Located in Isanti Township, Isanti County, Minnesota Pursuant to Minnesota

Statutes § 414.033 Subdivision 2 (3), Permitting Annexation by Ordinance

WHEREAS, a petition signed by all the property owners, requesting that property legally described herein be annexed to the City of Cambridge, Minnesota, was duly presented to the Council of the City of Cambridge on the 20th day of September, 2021; and

WHEREAS, said property is unincorporated, abuts the corporate boundaries of the City of Cambridge, is less than 120 acres; is not presently served by public wastewater facilities, and

WHEREAS, said property is more or less 4.82 acres; and

WHEREAS, the City of Cambridge gave proper prior notice to Isanti Township, all landowners, and contiguous property owners and held a public hearing pursuant to Minnesota Statutes § 414.033 subd. 2b on September 20, 2021.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CAMBRIDGE HEREBY ORDAINS AS FOLLOWS:

- 1. The City Council hereby determines that the property as hereinafter described is less than 120 acres, is not presently served by public wastewater facilities and the municipality received a petition from the property owners of the land.
- 2. None of the property is now included within the limits of any city, or in any area that has already been designated for orderly annexation pursuant to Minnesota Statute § 414.0325.
- 3. The corporate limits of the City of Cambridge, Minnesota, are hereby extended to include the property described below (and in Exhibit A):

PIN: 05.004.1900

That part of the Northwest Quarter of the Southeast Quarter of Section 4, Township 35, Range 23, Isanti County, Minnesota described as follows: Commencing at the northwest corner of said Northwest Quarter of the Southeast Quarter; thence South 3 degrees 32 minutes 06 seconds West along the west line of said Northwest Quarter of the Southeast Quarter, a distance of 655.11 feet to the intersection with the south line of YERIGAN FARMS 2ND ADDITION, according to the recorded plat thereof and also the point of beginning of the land to be described; thence North 89 degrees 29 minutes 29 seconds East along said south line of YERIGAN FARMS 2ND ADDITION, a distance of 561.08 feet; thence South 30 degrees 51 minutes 37 seconds West, a distance of 574.77 feet; thence North 89 degrees 56 minutes 32 seconds West; a distance of 296.38 feet to said west line of the Northwest Quarter of the Southeast Quarter; thence North 3 degrees 32 minutes 06 seconds East along said west line, a distance of 489.05 feet to the point of beginning.

- 4. That the area legally described herein is currently vacant and will not increase the population of Cambridge at this time.
- 5. That pursuant to Minnesota Statutes § 414.036 there are no special assessments assigned by the Town to the annexed property and the City of Cambridge shall pay to Isanti Township a reimbursement of \$126.10 (50% of the township taxes for 05.004.1900) on July 1 in the years of 2022, 2023, as is required by Minnesota Statutes § 414.036.
- 6. That the cost of electric utility service will not change upon annexation as indicated by the electric company pursuant to Minn. Stat. § 414.033, Subd. 13.
- 7. That the City Administrator of the City of Cambridge is hereby authorized and directed to file a copy of this Ordinance with the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings, the Minnesota Secretary of State, the Isanti County Auditor, and the Isanti Township Clerk.
- 8. That this Ordinance shall be in full force and effect and final upon the date this Ordinance is approved by the Office of Administrative Hearings.


