In the Matter of the Annexation of Certain Real Property to the City of Kilkenny from Kilkenny Township (MBAU Docket A-8368)

ORDER APPROVING ANNEXATION ORDINANCE

On October 14, 2021, the City of Kilkenny (City) adopted Ordinance No. 2021-1 (Ordinance) annexing certain real property (Property) from Kilkenny Township (Township) legally described as follows:

That part of Government Lot 7 of Section 22, Township 110 North, Range 23 West, Le Sueur County, Minnesota, described as follows: Commencing at the Southeast corner of Block 4, CORRECTED PLAT OF KILKENNY, according to the recorded plat thereof; thence North 00 degrees 00 minutes 00 seconds East (assumed bearing), on the East line of said Block 4 a distance of 120.00 feet to the Northeast corner of said Block 4 also being the point of beginning; thence North 89 degrees 42 minutes 06 seconds West on the North line of said Block 4 a distance of 180.00 feet to the Northwest corner of said Block 4; thence North 89 degrees 55 minutes 00 seconds West 20.00 feet to the East right-of-way line of the former Chicago Northwestern Railway; thence North 00 degrees 00 minutes 00 seconds East on said right-of-way line 153.00 feet; thence North 89 degrees 55 minutes 00 second East 310.00 feet; thence South 00 degrees 00 minutes 00 seconds East 154.20 feet to the North line of the Southwest Quarter of the Southeast Quarter of said Section 22; thence Westerly on said North line 110.00 feet to the point of beginning. ORDER

1. Pursuant to Minn. Stat. § 414.033 (2020), the Ordinance is deemed adequate in all legal respects and properly supports this Order.

2. Pursuant to the terms of the Ordinance and this Order, the Property is **ANNEXED** to the City.

3. Pursuant to the agreement of the parties and as allowed by Minn. Stat. § 414.036 (2020), the City will reimburse the Township a lump sum of \$75 as stated in Ordinance No. 2021-1.

4. The City must file a copy of the Annexation Ordinance with the Township, the appropriate county auditor(s), and the Secretary of State as required by Minn. Stat. § 414.033, subd. 7.
