WHEREAS, the territory described below is not presently within the corporate limits of any incorporated city, and

WHEREAS, the area proposed for annexation is 40 acres or less in size, is 60% or more bordered by land already within the corporate limits of the City of New York Mills and is not appropriate for annexation by ordinance pursuant to Minnesota Statutes § 414.033, Subd. 2(3); and

WHEREAS, the area proposed for annexation is described as follows:

See Exhibit A attached hereto and made a part hereof by reference.

WHEREAS, the area proposed for annexation abuts upon the corporate limits of the City of New York Mills, Minnesota; and

WHEREAS, the area proposed for annexation is unincorporated, abuts on the city's northern, southern, and western boundaries, and is not included within any other municipality; and

WHEREAS, the area proposed for annexation is approximately 21 acres in size; and

WHEREAS, the reason for the proposed annexation is; the area to be annexed already has city water, sewer, and gas. In order to continue maintaining and providing said services, the property needs to be annexed to the City of New York Mills; and.

WHEREAS, the nature of the area proposed for annexation is residential; and

WHEREAS, the area proposed for annexation is not included in any area that has already been designated for orderly annexation pursuant to Minnesota Statutes §

414.0325, nor in any other proceeding currently pending before the Office of Administrative Hearings - Municipal Boundary Adjustment Unit; and

NOW THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF NEW YORK MILLS, MINNESOTA that we hereby serve a Notice of Intent to annex the abovedescribed property into the corporate limits of the City of New York Mills, Minnesota on:

Newton Township; Otter Tail County; and the Municipal Boundary Adjustment Unit of the Office of Administrative Hearings.
