LAND LYING WITHIN THE CITY OF ST. CLOUD AND CONCURRENTLY ANNEX
WILSON PARK LAND LYING WITHIN THE CITY OF SAUK RAPIDS.

WHEREAS, portions of Wilson Park, a park wholly owned and operated by the City of St. Cloud, currently lies outside the City limits of the City of St. Cloud and in the City of Sauk Rapids; and,

WHEREAS, portions of Benton County Fairgrounds are presently within the corporate limits of the City of St. Cloud with the remainder lying entirely within the corporate limits of the City of Sauk Rapids; and

WHEREAS, it would be in the best interests of both the cities of St. Cloud and Sauk Rapids to concurrently detach and annex those properties to properly place administrative, maintenance, development and policing responsibilities.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF ST. CLOUD, MINNESOTA:

That the Council desires to detach that portion of the Benton County Fairgrounds legally described as follows:

Commencing at a point at the intersection of the Westerly right of way line of the Burlington Northern and the north line of the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$), Section 26, Township 36 North, Range 31 West; thence westerly along said north line of said Southeast Quarter of Southeast Quarter, following present City of Sauk Rapids corporate limits, to the point of intersection with the easterly line of Summit Street as originally platted as part of Sweet's Addition now vacated; thence southerly along said easterly line of Summit Street, following present City of Sauk Rapids corporate limits, to the point of intersection with the south line of Section 26; thence easterly along the south line of Section 26 to the point of intersection with the westerly right of way line of the Burlington Northern; thence north-westerly along said westerly right of way line to the point of beginning, and there terminating; all within Section 26, Township 36 North, Range 31 West.

BE IT FURTHER RESOLVED, that the Council desires to concurrently annex that portion of Wilson Park legally described as follows:

All of Block numbered Seventeen (17) and Lots numbered Nine, Ten, Eleven, Twelve, Thirteen and Fourteen (9, 10, 11, 12, 13, and 14) of Block numbered Thirteen (13) Sweet's Addition to the Town (Now Village) of Sauk Rapids according to the plat and survey thereof on file and of record in the office of the Register of Deeds in and for Benton County, Minnesota, together with that portion of River Avenue vacated from the south line of 14th Street South vacated, and the west one half of the vacated alley in Block numbered Thirteen.
