In re the Petition by all of the property owners for the concurrent detachment from the City of Branch and annexation to the City of North Branch of certain lands pursuant to M.S. 414.061(5)

We, the undersigned, being all of the property owners of the lands described in this Petition, hereby request the Minnesota Municipal Board to detach said lands from the City of Branch and annex said lands to the City of North Branch pursuant to Minnesota Statutes, Section 414.061(5).

The land described in this Petition and all of it is located in the County of Chisago, State of Minnesota, and is described as follows:

WHEREAS, The City of North Branch is the owner of the following described property, located in the City of Branch, County of Chisago, State of Minnesota, described as follows:

- The City Administrator is authorized and directed to coordinate all efforts necessary or incidental to informing the interested property owners and excepting from same all petitions for all qualifying property, all of which shall be submitted as an initiating petition to detach and annex, persuant to the law and rules of the Minnesota Municipal Commission.
- 2. Petitions shall be held until September 19, 1986 at 5:00 P. M. in anticipation of any other property owner to join said petition. The deadline is necessary due to the time requirement in planning and design of the upgrade of the new wastewater treatments facility.
- 3. Any petition submitted pursuant to this resolution, and the procedure set forth herein, shall be a voluntary act and submitted at the sole descretion of each petitioner.
- 4. By the adoption of this resolution the City Council authorizes the submittal of a petition for properties owned by the City as described above.
- 5. By the adoption of this resolution the City of North Branch makes no commitments to nor otherwise gives any assurances of either the annexation of said lands, or any of them, nor that any utilities, resources and financial capabilities of the city will permit.
