RESOLUTION AUTHORIZING THE ACQUISITION AND ANNEXATION OF RIGHT-OF-WAY FOR THE NORTH OPUS AREA STREET RECONSTRUCTION PROJECT NO. 4795

BE IT RESOLVED by the City Council of the City of Minnetonka, Minnesota, as follows:

Section 1. Background.

- 1.01. At its meeting of September 18, 1989, by Resolution No. 8939, the City Council ordered the preparation of a feasibility study for the North Opus Area Street Reconstruction Project No. 4795.
- 1.02. Pursuant to Resolution No. 89-8939, a report was prepared by the Engineering Department of the City of Minnetonka with reference to the North Opus Area Street Reconstruction, and this report was received by the City Council on June 18, 1990, with the project to be known as:

NORTH OPUS AREA STREET RECONSTRUCTION PROJECT NO. 4795

- 1.03. At its meeting of June 18, 1990, by Resolution No. 90-9051, the City Council ordered the improvement as proposed.
- 1.04. The improvement as proposed includes land located within the City of Hopkins adjoining the City of Minnetonka. Additional easements are needed from the land located within the City of Hopkins. Approval would normally be required from the City of Hopkins for the improvement as proposed.

Additionally, the City of Minnetonka is proposing to use Municipal State Aid funds for the improvement which would also normally require that the City of Hopkins approve the designation of the improvement as a State Aid Street.

1.05. The City of Hopkins does not have any Municipal State Aid funds to use toward the improvement project nor do they have any additional mileage necessary to designate the roadway as a State Aid Street.

1.06. The City of Minnetonka does have Municipal State Aid funds to use toward the improvement project and additional mileage necessary to designate the roadway as a State Aid Street.

Section 2. Findings.

- 2.01. The City Council of the City of Minnetonka, Minnesota finds that the City of Hopkins does not have any Municipal State Aid funds to use toward the improvement project as proposed, nor do they have any additional mileage necessary to designate the roadway as a State Aid Street.
- 2.02. The City Council of the City of Minnetonka, Minnesota finds that it has sufficient Municipal State Aid funds to use toward the improvement project as proposed and the additional mileage necessary to designate the roadway as a State Aid Street.
- 2.03. The City Council of the City of Minnetonka, Minnesota finds that the public interest will be served by acquiring and annexing the needed right-of-way from land located within the City of Hopkins adjoining the City of Minnetonka in order to obtain Municipal State Aid funds.

Section 3. Council Action.

- 3.01. The City Engineer and the City Attorney are hereby authorized to negotiate for the acquisition and annexation of land located within the City of Hopkins for right-of-way.
- 3.02. The City Engineer and the City Attorney are hereby authorized to acquire necessary easements by negotiation or by condemnation.
- 3.03. The Mayor and the City Manager are hereby authorized to execute any legal documents necessary to acquire and annex land located within the City of Hopkins for right-of-way.
