3. This property consists entirely of agricultural land and one building site with appurtenances.

4. There are no city utilities or improvements to that area.

5. There has been no development for urban residential, commercial, or industrial purposes.


6. There is one residence with a population of three residing thereon.

7. The property consists of 20 acres more or less.


8. Said property is contiguous to the City of Dawson on its north boundary only and is contiguous to Riverside Township property on the east, south and west boundaries.



BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DAWSON, MINNESOTA.


1. It is hereby found and determined that the territory to be detached described in the petition meets the statutory requirement for detachment from the City of Dawson.

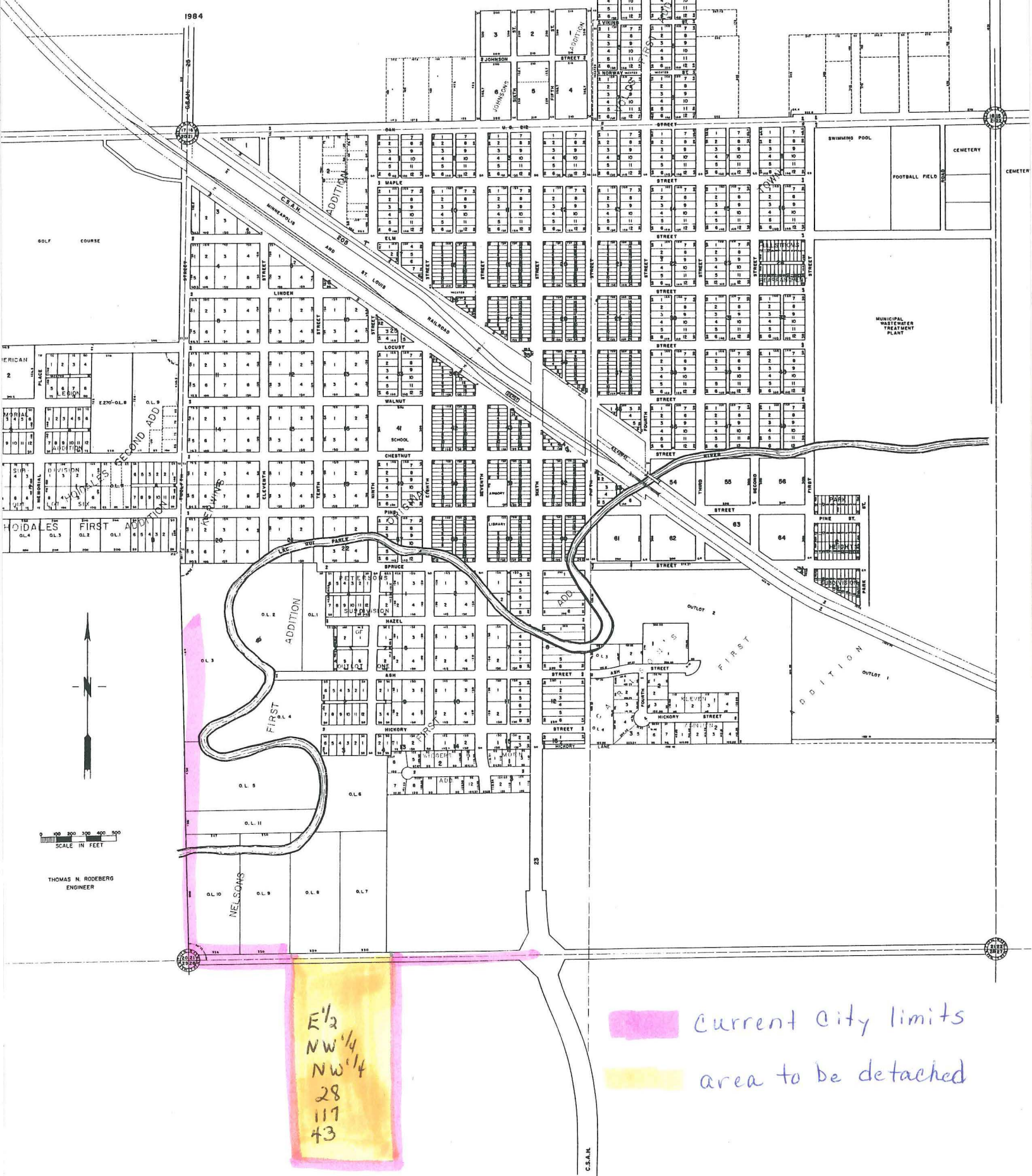
