On June 14, 2000, the Office of Strategic and Long Range Planning received a joint resolution from the Cities of Inver Grove Heights and South St. Paul, requesting the detachment of certain property from the City of South St. Paul and annexation of the same property to the City of Inver Grove Heights pursuant to Minnesota Statutes 414.061.

After review of the resolution, the Director of the Office of Strategic and Long Range Planning hereby makes and files the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. That a resolution requesting concurrent detachment and annexation of certain property was received from the Cities of South St. Paul and Inver Grove Heights.
2. The resolution contained all the information required by statute including a description of the territory proposed for concurrent detachment and annexation,

which is as follows:

That part of Lot 6, Block 1, DAWN WAY RIDGE, Dakota County, Minnesota which lies within Section 3, T.27N., R.22W., said Dakota County.

3. The area proposed for concurrent detachment and annexation is situated within the City of South St. Paul and abuts the municipal boundary of the City of Inver Grove Heights.

CONCLUSIONS OF LAW

1. The Office of Strategic and Long Range Planning has duly acquired and now has jurisdiction of the within proceeding.

2. An order should be issued by the Director of the Office of Strategic and Long Range Planning concurrently detaching and annexing the area described herein.

ORDER

1. IT IS HEREBY ORDERED: That the property described in Findings of Fact 2 be, and the same hereby is, detached from the City of South St. Paul and annexed to the City of Inver Grove Heights, the same as if it had originally been made a part thereof.

2. IT IS FURTHER ORDERED: That the effective date of this order is July 14, 2000.
