PURSUANT TO MINNESOTA STATUTES § 414.06

Pursuant to the 2012 amendment to Minn. Stat. § 414.06, the petitioner(s) shall also provide a copy of this petition to:

- 1) the city from which the land may be detached;*
- 2) all property owners who have not signed this petition;*
- 3) the clerk of the town to which the property may be attached if granted;*
- 4) the clerk of any other abutting town or city; and*
- 5) the county recorder in the county in which the land is located.*

PETITIONERS STATE: That the area to be detached is more than 40 acres in size; and the Petitioner represents 75% or more of the property owners of the area to be detached.

It is hereby requested by:

 all of the property owners, the area is less than 40 acres; or
 X 75% or more of the property owners, the area is more than 40 acres;
to detach certain properties described herein from the City of Breezy Point and make a part of the Township of Ideal.

1. There are 135 property owners in the area proposed for detachment; 102 property owners need to sign the petition to commence this proceeding.
2. 122 property owners have signed this petition. (If the land is owned by both the husband and wife, both must sign the petition to represent all owners.)
3. The property situated within the City of Breezy Point, abuts the township boundary, and is located in the County of Crow Wing. The petitioned area abuts on the city's North boundary.
4. The property proposed for detachment is rural in character and not developed for urban residential, commercial, or industrial purposes.

5. The reason detachment is requested is that the properties seeking to be detached are physically separated from the remaining properties located in the City of Breezy Point by Lake Ossawinnamakee. The vast majority of the properties along Ossawinnamakee Road are within Ideal Township; and the majority of the properties seeking to be detached abut Ideal Township. In fact, no matter which route you take, you must travel through Ideal township to get to the properties seeking to be detached. The properties seeking to be detached are rural residential in character and, therefore, more in keeping with a township. The only public improvement is a paved road and Ideal Township provides all essential services, such as road plowing and ditch mowing, for the road. There is no city water or sewer, and the city of Breezy Point has no plans to provide such services to the properties. While both fire departments provide services, the Ideal fire station is approximately half the distance of the Breezy Point fire station. Finally, it only makes sense that all the residences in the area be part of Ideal township so that they have a common set of ordinances, a common building code and a common sense of community.

6. Summarize what efforts were taken prior to filing this petition to resolve the issues: The property owners have had conversations with both the Township of Ideal and the City of Breezy Point. The Township is neutral on the issue of detachment. The City is opposed.

7. The number of acres in the property proposed for detachment is 83.97 and is described as follows:

8. The number and character of buildings on said property is: 535 ATTACHED EXH. B

9. The number of residents in the area proposed for detachment is 135.
(The number of residents is not necessarily the same as number of owners.)

10. Public improvements on said property are: the only improvement is Ossawinnamakee Road. None of the properties in question are served by sanitary sewer, storm sewer, or water provided by the City of Breezy Point, and there are no plans to do so in the future. All properties are serviced by private waste systems and wells.
